- (2) Within the past 12 months, the department has successfully placed 46 registrable employees either internally with the department or across the broader WA public sector.
- (3) Meaningful work will be assigned to registrable employees as soon as practicable whilst the department case manages registrable employees in accordance with the Public Sector Management (Redeployment and Redundancy) Regulations 2014. Meaningful work, when possible, should be appropriate to the employee's classification, skills and experience and may include opportunities for on-the-job training and development including job shadowing and mentoring to maximise employment transition outcomes for registrable employees and may include short-term or long-term opportunities. When possible, the department will source funded meaningful work whilst new suitable positions are identified.
