Mr. LOGUE reverted to the action taken by His Excellency in regard of the duty placed upon flour at the last session of Council, by a majority of the House, and his subsequent appeal to the country on the question; a course which he (Mr. Logue) characterised as injudicious and unconstitutional. The country, however, had affirmed the decision of the Council by returning again to the House representatives known to be protectionists. He thought that in the face of this His Excellency would have observed a nice sense of political honor had he left the nominee members to vote according to their views on this question. But he was sorry to find that His Excellency had not done so; but, on the contrary, had asked them to pledge themselves to support the Government in this matter, a fact to which the absence of one of the late nominee members from the present Council was to be attributed. He considered that the action of His Excellency in this was neither fair nor honest towards the Council nor the Colony.

Mr. STEERE and Mr. NEWMAN concurred.

The COLONIAL SECRETARY (Hon. F. P. Barlee) was prepared to make every possible allowance for the disappointement of hon. members who had taken a keen interest in the question of a duty on flour, and who had expected to have been able to carry out their wishes in that respect at the present session; but he certainly had not anticipated that hon. members would have so far forgotten themselves as to attribute unfairness and political dishonor to His Excellency the Governor. He (the Colonial Secretary) would consider himself unworthy of the position which he held in the House and in the Government did he allow such remarks to pass by unchallenged, though it would be mere insult on his part to attempt to defend His Excellency from such accusations as those levelled at him by the hon, member for Geraldton, who had attributed to the Governor a lack of a "keen sense of political honor." He would tell the hon. gentleman that His Excellency's sense of honor was as keen as that of any member of that House.

Mr. LOGUE: The hon, member questioned it.

The COLONIAL SECRETARY (Hon. F. P. Barlee) said he did not think that any man in the House was likely to question the keen

sense of honor of any English gentleman, whose reputation from his boyhood upwards had been unsullied. His Excellency had pledged no nominee member to vote against his conscience; but having submitted to them a broad outline of the policy of the Government, he asked them, prior to their nomination, if their views were in accord with the general principles of that policy. If not, they were at liberty to decline the position offered to them.

Mr. BUSSELL indignantly resented the insinuation that he had been asked to pledge himself to a free trade policy conditionally upon his accepting the position of a nominee member.

Mr. BICKLEY positively denied having been requested to pledge himself to support His Excellency's Government on this or any other question, contrary to his convictions.

Mr. MARMION also indignantly refuted the assertion made by the hon. member for Geraldton.

Mr. STEERE, in accordance with notice, moved that an humble Address be presented to His Excellency the Governor, requesting him to instruct the resident magistrate of the Murray district to hold a Court of Petty Sessions at least once a month at the Williams and assuring His Excellency that the Council is willing to vote an increase of salary of £50 per annum, which, together with his present pay and allowances, the Council is of opinion is amply sufficient remuneration of the work to be performed by the above-mentioned official.

The COLONIAL SECRETARY (Hon. F. P. Barlee) said His Excellency could not entertain such a memorial, it being a distinct interference with his prerogative.

#### REWARD FOR PAYABLE GOLD-FIELD.

Mr. LOGUE, in accordance with notice, moved that the Government be empowered to offer a reward to any person or persons who will discover a workable gold-field within a radius of 300 miles from any declared port in the colony, the amount of reward to be in proportion to the number of ounces of gold exported, being the produce of such gold-field;
