21 22	4.	Busselton Water Board may supply water to the Water Corporation
23 24 25	(1)	The Board may supply water to the Corporation, on such terms and conditions as are agreed, to facilitate the supply of water to the Dunsborough area.
26 27 28	(2)	To the extent to which the Board is not otherwise empowered to do so, the Board may do all things necessary or convenient to be done for or in connection with giving effect to subsection (1).


