STANDING COMMITTEE ON PUBLIC ADMINISTRATION - INQUIRY INTO WORKSAFE WA

Thank you for your correspondence dated 9 July 2018, requesting information to assist the above inquiry.

Western Australia Police Force (WA Police Force) officers are appointed as coroner's investigators, acting on the Coroner's behalf, under the provisions of Section 14(2) of the *Coroners Act* 1996 (the Act). The Coronial Investigation Squad investigates all reportable deaths on behalf of the Office of the State Coroner, including suicide.

WA Police Force policy exists for the Scene of Death to notify appropriate authorities, which includes WorkSafe WA . WA Police Force policy exists where WorkSafe WA should be contacted where the death of a person occurred at a worksite and there are no suspicious circumstances. A copy of this policy is attached for the information of the committee.

In relation to the specific questions from the committee, the WA Police Force provide the following responses:

1.1 Are WA Police required as part of their investigation of a suicide, to inquire whether the suicide was caused by or connected to the person's employment?

Police attend all Reportable Deaths as defined within Section 3 of the Act and undertake investigations with the principal role of making an initial determination of whether the death has occurred under any suspicious circumstances.

Police officers are prohibited by the Act from making comment on the cause and manner of death as only the Coroner can make a finding and comment as prescribed in Section 25(1) of the Act.

All information collected in the course of the police investigation is provided to the Coroner in accordance with the Act.

Yes. The Worksafe WA investigation would be considered with information obtained by WA Police Force when preparing the coronial investigation file for the Coroner.
