#### Chairman's Foreword

he 2019–20 financial year was busy for the Community Development and Justice Standing Committee. Our primary focus was our inquiry into the Magistrates Court of Western Australia's management of matters involving family and domestic violence. The inquiry had the Committee considering 47 submissions, and 13 supplementary submissions, and speaking with 84 witnesses at 12 public hearings and 15 briefings. It took us on a short and tightly packed trip to Melbourne, Canberra, Southport and Brisbane, where we gathered a significant amount of evidence which informed the course of the Committee's inquiry and, ultimately, the findings and recommendations made in our inquiry report this year.

As with everyone across Western Australia, the Committee's activities were impacted by the COVID-19 pandemic. Scheduled travel in early April 2020 to the Barndimalgu Aboriginal Family Violence Court in Geraldton was cancelled due to health concerns and increasing restrictions on movement. Further evidence gathering hearings were cancelled, and information instead sought in writing. As the Committee adjusted to restrictions on movement and gathering sizes, and working from home requirements, meetings were cancelled or rescheduled to be conducted remotely. These disruptions contributed to the Committee extending its inquiry tabling date from 25 June 2020 to 13 August 2020.

The pandemic also impacted our other activities. The Committee had begun considering potential new inquiries, with a scoping hearing scheduled for May 2020. This hearing was cancelled due to movement and gathering restrictions, and also in recognition of the need for government agencies to focus on service provision and their response to the rapidly evolving COVID-19 pandemic, whilst ensuring the health and safety of staff and the public. The Committee was thus unable to commence another inquiry during the 2019–20 period as we had intended.

Movement and gathering restrictions, coupled with health and safety concerns, required the Committee to change the way we operate to continue our work. The Committee held a number of meetings via Zoom, including over the winter Parliamentary recess, to adopt our inquiry report. Utilising remote conferencing technology provided flexibility for the whole Committee in allowing us to meet more regularly. It was particularly beneficial for our regional members who are not regularly in Perth during the recess, and would otherwise have been required to travel for hours to attend meetings, or missed the opportunity to take part in deliberations.

Although adopted as a necessity borne out of a challenging situation, the willingness of Committee members to embrace remote conferencing technology, and the smoothness with which our meetings ran, was encouraging. Continuing to use this technology into the future for both deliberative meetings and evidence gathering hearings, particularly with interstate and international witnesses, will provide flexibility for Committee meetings, ultimately enhancing the way the Committee conducts its activities.

The Committee looks forward to continuing its work for the duration of this Parliament and has a series of hearings scheduled for the next few months.

## **Chapter 1**

#### **Committee Activities**

#### Introduction

This report covers the works undertaken by the Community Development and Justice Standing Committee of the  $40^{th}$  Parliament during the 2019–20 financial year. During the period 1 July 2019 – 30 June 2020, the Committee:

- conducted the inquiry into the Magistrates Court of Western Australia's management of matters involving family and domestic violence
- held 22 deliberative meetings
- took evidence from 24 witnesses at 12 public hearings, and held three closed hearings
- met with 60 people at 15 briefings, including a site visit at the Perth Magistrates Court
- undertook investigative travel to Melbourne, Canberra, Southport and Brisbane as part
  of the inquiry into the Magistrates Court of Western Australia's management of
  matters involving family and domestic violence
- tabled one report, the 2018–19 Annual Report.

#### **Briefings**

In addition to gathering evidence during formal hearings, the Committee held one briefing with the Chief Magistrate, and attended a site visit at the Magistrates Court of Western Australia. The Committee obtained information at the briefings in relation to the inquiry into the Magistrates Court of Western Australia's management of matters involving family and domestic violence.

#### **Investigative Travel**

As part of its inquiry into the Magistrates Court of Western Australia's management of matters involving family and domestic violence, five Committee members, one co-opted Committee member and two staff members undertook investigative travel to Melbourne, Canberra, Southport and Brisbane for five days in February 2020.

The Committee's travel gave it the opportunity to explore how other state and territory court systems are structured to respond to matters involving family and domestic violence. The Committee met with representatives of magistrates' courts in Victoria, Queensland and the Australian Capital Territory to understand court processes, and toured court buildings to view infrastructure and design features implemented specifically to respond to matters involving family and domestic violence. The Committee also took the opportunity to meet with representatives of legal and support service providers to gain an understanding of how different court users experience court processes in each jurisdiction, and improvements that could be made to make processes more efficient and accessible.

The Committee gathered important evidence during its travel. This evidence was relied upon by the Committee when forming many of its conclusions and making recommendations throughout the Committee's report, *Opening doors to justice: Supporting victims by improving the management of family and domestic violence matters in the Magistrates Court of Western Australia*.

The Committee intended to visit to the Barndimalgu Aboriginal Family Violence Court in Geraldton in early April 2020. Unfortunately, the scheduled trip was cancelled due to public health concerns and increasing restrictions on movement arising from the COVID-19 pandemic.

## **Chapter 2**

#### **Financial Statement**

The Committee does not have its own formal budget and is funded out of the budget of the Legislative Assembly. Approval for major expenditures is required on a case-by-case basis and is entirely at the discretion of the Speaker.

### **Appendix One**

#### Committee's functions and powers

The functions of the Committee are to review and report to the Assembly on: -

- a) the outcomes and administration of the departments within the Committee's portfolio responsibilities;
- b) annual reports of government departments laid on the Table of the House;
- c) the adequacy of legislation and regulations within its jurisdiction; and
- d) any matters referred to it by the Assembly including a bill, motion, petition, vote or expenditure, other financial matter, report or paper.

At the commencement of each Parliament and as often thereafter as the Speaker considers necessary, the Speaker will determine and table a schedule showing the portfolio responsibilities for each committee. Annual reports of government departments and authorities tabled in the Assembly will stand referred to the relevant committee for any inquiry the committee may make.

Whenever a committee receives or determines for itself fresh or amended terms of reference, the committee will forward them to each standing and select committee of the Assembly and Joint Committee of the Assembly and Council. The Speaker will announce them to the Assembly at the next opportunity and arrange for them to be placed on the notice boards of the Assembly.
