CHAPTER	2 FINANCIAL STATEMENT	

COMMITTEE'S FUNCTIONS AND POWERS

The functions of the Committee are to review and report to the Assembly on: -

- (a) the outcomes and administration of the departments within the Committee's portfolio responsibilities;
- (b) annual reports of government departments laid on the Table of the House;
- (c) the adequacy of legislation and regulations within its jurisdiction; and
- (d) any matters referred to it by the assembly including a bill, motion, petition, vote or expenditure, other financial matter, report or paper.

At the commencement of each Parliament and as often thereafter as the Speaker considers necessary, the Speaker will determine and table a schedule showing the portfolio responsibilities for each committee. Annual report of government departments and authorities tabled in the Assembly will stand referred to the relevant committee for any inquiry the committee may make.

Whenever a committee receives or determines for itself fresh or amended terms of reference, the committee will forward them to each standing and select committee of the Assembly and Joint Committee of the Assembly and Council. The Speaker will announce them to the Assembly at the next opportunity and arrange for them to be placed on the notice boards of the Assembly.

CHAIR'S FOREWORD

This report, the third annual report of the Economics and Industry Standing Committee of the thirty-seventh Parliament of Western Australia, provides a brief overview of the Committee's activities for the period 1 July 2006 - 30 June 2007. This is also my first report as Chair of the Committee, having been appointed to the Committee by the Legislative Assembly on 21 June 2007 and subsequently elected as Chair, a position I am proud to hold.

I would like to acknowledge the very significant role played by Ms Jaye Radisich, MLA, during her membership of the Committee. Ms Radisich held the position of Chair from the Committee's establishment by the thirty-seventh Parliament until her resignation from the Committee in June 2007. The Committee thanks Ms Radisich for her energy, enthusiasm and commitment to the Committee's work.

On 14 June 2007 the Committee tabled its major report on the state government's role in developing and promoting the information communications technology (ICT) industry in Western Australia. This report represents the culmination of an inquiry the Committee commenced in June 2006. As part of its investigations the Committee held 8 hearings, gathering evidence from 21 witnesses. The Committee also held 25 formal deliberative and adoption meetings during the reporting period. The ICT inquiry report reached 67 findings and made 34 recommendations to government. The Committee has requested that the Minister for Energy; Resources; Industry and Enterprise report to the Assembly any actions proposed by the government with respect to the report's recommendations. The government is required to formally respond within 90 days. The Committee has also invited the Premier in his capacity as Minister for Science; Innovation to respond to the ICT report and its recommendations.

At the time of writing, the Committee is considering a number of potential areas for inquiry ranging from adventure tourism, the safety of mine site accommodation, the adoption of clean coal technology, waste oil recovery and recycling, anti-trust and competition policy issues and suburban waste recovery. Discussions regarding the Committee's next inquiry have raised another important issue, namely the extensive range of portfolios allocated to the Committee. Pursuant to Standing Order 287(3), the Economics and Industry Standing Committee has 16 portfolio responsibilities with such diverse areas as heritage, science, regional development, racing and gaming, planning and infrastructure, and consumer and employment protection, to list but a few. With regards to these portfolio responsibilities, the Committee is charged with reviewing and reporting to the Assembly on the outcomes and administration of relevant departments, departmental annual reports tabled in the Assembly, and the adequacy of portfolio-relevant legislation and regulations. The Committee is also required to investigate and report on any matters referred to it by the Assembly. It should be noted that the Committee is comprised of 5 members and is supported by a secretariat of 2. Given this, it is not possible for the Committee to adequately fulfil its allocated review and report functions without a significant increase in resources.

Standing Committee portfolio workloads and staffing levels have been raised previously by the Committee in its March 2006 submission to the Legislative Assembly's Procedure and Privileges

Committee's Review of the Legislative Assembly's Committee System and Other Matters. It is disappointing to note that to date the Procedure and Privileges Committee has yet to report its findings.

The Committee's 2005-2006 annual report noted that at the time of its writing the government response to the *Inquiry into the Production and Marketing of Foodstuffs* report had not been forthcoming. The response to this inquiry has now been received and I am pleased to report that all of the 11 recommendations made have received government support. As a result of this Inquiry, in September 2006, the Minister for Agriculture and Food, the Hon. Kim Chance, MLC, announced funding for a voluntary 'Buy WA Food First' certification and marketing scheme and for the annual pesticide testing of fruit and vegetables. Since then, the Committee has met with the minister to discuss the agency timelines and programs that are required to give effect to the government response to the Committee's Inquiry.

I am pleased to advise that the Economics and Industry Standing Committee will host a university student as a parliamentary intern who will undertake a research project during second semester 2007. While the parliamentary internship programme has been running for some time, this is the first intern attached to the Legislative Assembly Committee Office, and I look forward to our involvement with this initial placement.

I would also like to take this opportunity to formally thank the members of the Committee for their dedication and commitment to the work of the Committee. This has been signal in the Committee's achievements, particularly with regard to the ICT inquiry which was the main focus of the Committee's activities over the past year. Thanks must also go to the Committee's former Principal Research Officer, Ms Jessica Shaw, and particularly to former Research Officer, Ms Jovita Hogan who also 'held the fort' as Acting Principal Research Officer for a period. Ms Hogan's efforts on behalf of the Committee are sincerely appreciated. Finally, I would like to thank the Committee's current secretariat, Dr Loraine Abernethie (Principal Research Officer) and Mr Peter Frantom (Research Officer) for their assistance afforded to the Committee.

CHAPTER 1 COMMITTEE ACTIVITIES

- Conducted 1 Inquiry;
- Held 25 deliberative meetings;
- Took evidence from/or was briefed by 47 persons;
- Undertook investigative travel to Melbourne, Canberra and Nevada; and
- Attended 3 conferences.

At the ICT Enabling Growth conference in Perth, October 2006, the Chair participated in the panel session, presenting an overview of the Committee's ICT inquiry.

1.4 Investigative Travel

The Committee travelled to Melbourne and Canberra for a series of briefings from government agencies, industry groups and individuals in relation to its Inquiry. The Committee also gathered evidence at the International Consumer Electronics Show in Nevada, the ICT Outlook Forum in Melbourne and the ICT Enabling Growth conference in Perth. The people the Committee spoke with at the briefings are listed in Tables 1.2 and 1.3 above.

1.5 Conferences

The Committee attended 3 conferences in relation to the ICT Inquiry.

- ICT Outlook Forum, Melbourne, October 2006;
- ICT Enabling Growth, Perth, October 2006; and
- International Consumer Electronics Show (CES), Nevada, January 2007.

The Committee took the opportunity to combine attending the ICT Outlook Forum with the briefings held in Melbourne and Canberra, as listed in Table 1.3. While in Melbourne the Committee also attended the Australian Electrical and Electronic Manufacturer's Association (AEEMA) Excellence Awards.

1.6 Reports Tabled

The Committee tabled 2 reports during the period 1 July 2006 - 30 June 2007. These were:

- Report No.5 Annual Report 2005-2006; and
- Report No.6 The State Government's Role in Developing and Promoting Information Communications Technology (ICT) in Western Australia.

1.7 Work in Progress

(i) Inquiry

Having tabled its ICT inquiry report on 14 June 2007, the Committee has not yet decided upon its next inquiry. At present the Committee is developing its background knowledge on a range of topics for consideration. To this end, it is conducting a series of briefings to develop a better understanding of the issues before reaching a decision on which inquiry to pursue.

(ii) Submission

In May 2007 the Committee made a supplementary submission to the Legislative Assembly's Procedure and Privileges Committee's *Review of the Legislative Assembly's Committee System and Other Matters*.

The matter raised in this submission was the inclusion of Committee Member attendance at Committee meetings in the Committee report for each Inquiry and in its Annual Report.

The Committee is currently awaiting the outcome of Procedure and Privileges Committee's Review.

CHAPTER 2 FINANCIAL STATEMENT

The Economics and Industry Standing Committee does not have its own formal budget and is funded out of the budget of the Legislative Assembly. Approval for major expenditures is required on a case-by-case basis and is entirely at the discretion of the Speaker.
