INTERIM REPORT ON LINKS BETWEEN GOVERNMENT AGENCIES AND THE FAILED WESTERN WOMEN GROUP.

TERMS OF REFERENCE

The Terms of Reference of the Committee are as follows:

- 1. The Legislative Council do appoint a committee to inquire into the links between government agencies and the failed Western Women's Group, in particular to determine whether the state bears any legal responsibility for persons relying on the investment advice of that Group to their loss.
- 2. The Parliament of Western Australia consider legislation that may be necessary to prevent a recurrence of the events which led to the loss by investors who relied on the Western Women Group or at least to ensure that the problems associated with such an operation are detected at an earlier stage.

CURRENT POSITION OF THE COMMITTEE

The Committee is in the process of evaluating the voluminous quantity of evidence to date. This evidence comprises the following:

(i) Witnesses

Evidence from seventeen witnesses (see appendix A), including;

- investors in the Western Women Group
- past employees of the Western Women Group
- past employees of the Women's Information and Referral Exchange (WIRE)
- representatives from the Women's Advisory Council (WAC)
- representatives from the South West Development Authority (SWDA), and
- representatives from the Office of Women's Interests (OWI)

(ii) Written Submissions

Thirty-eight written submissions were received from investors in the Western Women Group, in response to the Committee's first advertisement requesting comments or evidence in relation to the Committee's *terms of reference. The* Committee received sixty responses to a further advertisement calling for investors who had allegedly been introduced to a Western Women company by a government agency, out of those sixty, eleven had previously responded.

(iii) Subpoenaed Documents

Several thousand documents have been subpoenaed from Women's Information and Referral Exchange (WIRE), South West Development Authority (SWDA), Great Southern Development Authority (GSDA), Office of Women's Interest (OWI), Women's Advisory Council (WAC), Public Service Commission and the R & I Bank.

(iv) Parliamentary Commissioner for Administrative Investigations

By resolution of the Committee, information which is protected by *Parliamentary Privilege* has been supplied to the Ombudsman as part of his investigation, as set out by the Legislative Assembly. The Ombudsman advised the Committee accordingly on the documents he wished to quote from in his report (see appendix B).

(v) Legal Aid Commission

The Legal Aid Commission which is representing investors from the Western Women Group of companies, requested access to the Committee's subpoenaed documents in an attempt to help provide an information base or source from which their investigations could begin. By resolution of the committee, the Legal Aid Commission was authorised to have access to the Committee's documents.

ANTICIPATED PROGRESS OF COMMITTEE

The two most recent witnesses, Ms Janet Payton (formerly of SWDA and OWI) and Ms Lyn Amoore (formerly of WAC), completed their evidence on September 2, 1992. Once the record of the evidence of these two witnesses has been corrected and reviewed, the Committee will be in a position to call further witnesses.

After hearing the evidence of these witnesses, the Committee will consider compiling a further interim report on the alleged links between government agencies and the Western Women Group.

The Committee will also be investigating the interaction between the R&I Bank and Western Women Group. It will examine in particular the conduct of the R&I Bank in relation to accounts held by entities in the Western Women Group and the personal account/s of Robin Greenburg. Subpoenas for this information have already been issued.
