This water flows to the south-east and spreads across one of the former Balgold leach pads where most probably evaporates. ... The north wall seepage appears to be from a more diffuse source near the junction of the Oroya tailings dam and the disused Balgold tailings dam. The rate of flow through a conduit under a temporary bund wall was estimated to be about 1/2/L/sec, and KCGM staff have indicated that this flow rate has been consistent for some time. This seepage joins with other seepage coming from the area around the Goloconda plant a short distance to the north-west. All of this seepage migrates to the east for a few hundred metres across several of the former Balgold leach pads before evaporating and/or infiltrating through damaged pad liners.?
