The President made the following Statement —

Today marks 20 years since the devastating terrorist bombings in Kuta, Bali, Indonesia.

We recall the scenes of horror and overwhelming shock and despair.

We remember with love and respect the 202 people, including 88 Australians, 16 who were Western Australian, whose lives were tragically taken.

We offer our continued deepest sympathy to the families and loved ones of those who will never return home.

We reflect on the difficult road to recovery for all the people injured and affected by the trauma of those dreadful events.

We sincerely thank all those who assisted with first aid, care, evacuation and then treatment and care in hospitals in Western Australia and who continue to provide support and care.

And those who assisted with investigating and prosecuting these horrendous crimes.

We will never forget.
