1. Meeting of Council

The Council assembled at 2.00pm pursuant to order.

The President, Hon Kate Doust, took the Chair.

Prayers and an Acknowledgement of Country were read.

3. Statement by President — COVID-19 Sitting Arrangements

The President made the following Statement —

The Clerk sent you an email yesterday advising arrangements that had been made for sitting this week. I confirm that, following consultation with the Party Leaders, the following arrangements have been made for this week's sitting.

Seating Arrangements

You will notice the seating arrangements have been altered to ensure social distancing. Party Leaders, Ministers and Whips have allocated seats and other Members may sit in unallocated seats designated as "Member" on the chart that the Clerk emailed you yesterday. Unallocated seats are available on a rotational basis in accordance with directions from Party Whips.

I have designated the President's Gallery as the Floor of the House and Members may also use this seating. Members with allocated seating may speak from their place and other Members are asked to use the lectern positioned adjacent to the Table of the House. The Leader of the House intends to move a motion without notice to suspend so much of Standing Order 35 to give this effect.

Members whose seat is unallocated may collect their papers from the Administration Office.

Doors and Bar of the House

Chamber doors and the Bar of the House will remain open at all times and will be manned by Chamber staff at the usual times, for example during Divisions.

Hygiene and Social Distancing

Admission to the Chamber is subject to all persons strictly adhering to hygiene requirements. Hand sanitiser is available at each of the entrances to the Chamber and all persons are required to use this on entry to the Chamber. Please also follow other health guidelines

including only attending if you are well, coughing and sneezing into your elbow or a tissue and immediately discarding it in a bin, and maintaining appropriate social distance. It would assist if Members only attend in the Chamber if they intend to speak, in cases where an absolute majority is required, or for quorum requirements.

Advisers

I have authorised Government Advisers sitting behind the President's dais to attend to their relevant Minister in the Chamber unescorted for the purpose of passing notes containing advice so as to minimise Chamber staff movements. During Committee of the Whole, Advisers will continue to sit at the Table of the House along with the Minister.

Committee of the Whole

The Chair of Committees and Deputy Chairs will sit in the President's Chair during Committee of the Whole House.

Divisions

Divisions will be conducted without the need for Members to cross the Chamber. Those voting with the Ayes will stand and those voting with the Noes will sit. The Leader of the House intends to move a motion without notice to suspend so much of Standing Order 79 to permit this to occur.

Question Time

Hard copy answers will not be distributed in the Chamber. Answers will be provided to Members by email via the Parliamentary Liaison Officer, Janice Shaw, to minimise staff movement in the Chamber and handling of papers. Should you require a hard copy, please advise Janice who can print this for you to collect after Question Time.

Parties are strongly encouraged to arrange for their Leader or other Member deputed to ask all questions on behalf of other Party Members.

Hansard

Hansard will be reporting remotely and will not be present on the floor of the House. For this reason it is imperative you use the microphone at the lectern if you do not have a designated seat. Please email Hansard any speech notes at the conclusion of your speech as Chamber staff will not be collecting notes.

Afternoon Tea, Lunch, Dinner and Supper Service

As previously advised, there will be no food and beverage service in the Legislative Council Members' lounge until further notice. This will be coordinated from the Members' Dining Room. Members are encouraged to stagger their attendance in the Members' Dining Room to facilitate the meal service. Afternoon tea for Legislative Council Members will be available from 4.00pm.

10. Temporary Order — COVID-19 Arrangements

The Leader of the House moved, without notice —

If, following agreement with the party leaders or Members deputed, the Leader of the House or the Member deputed by the Leader advises the House that it is necessary to introduce a Government Bill or undertake any other immediate business arising from or in connection to COVID-19, the following Temporary Order shall apply in respect of those matters:

- (1) Any business then before the House, other than formal business, a matter of privilege, or a motion subject to SO 67 shall be adjourned to a later hour.
- (2) Any such Bill may be introduced without notice and shall proceed through its stages at dates and times determined by the House.
- (3) Any such Bill the subject of a Message from the Legislative Assembly may be taken into consideration on the day on which it is received.
- (4) On any sitting day, and after first consulting with the party leaders or Members deputed, the President may order that one or more of the following items of business in the order of business for that day be dispensed with:
 - (a) Non-Government Business;
 - (b) Private Members' Business; and
 - (c) Consideration of Committee Reports.
- (5) If ordered, the Council shall sit beyond the following times on the days specified until Members' Statements are called by the President and, in such case, SO 5(5) applies:

Tuesday 9.45pm; Wednesday 6.20pm; and Thursday 5.20pm.

- (6) After first consulting with the party leaders or their representatives, the Leader of the House or a Member deputed may set maximum time limits for each stage of a Bill or a motion and on the expiry of that maximum time limit all questions relating to the stage of a Bill or motion, including any amendment, shall be put and determined *seriatim*.
- (7) A requirement for notice to be given in respect to any motion to be moved by the Leader of the House or a Minister is dispensed with.
- (8) That, in the event that a scheduled sitting day of the House does not take place, the usual process for Questions on Notice that would have occurred on that day, shall still occur.
- (9) Standing Orders are suspended accordingly to the extent necessary to effect these arrangements.
- (10) This Temporary Order to apply until 27 November 2020 or the lifting of the state of emergency declared in Western Australia arising from the COVID-19 pandemic, whichever occurs first.
