- (b) does the Minister agree that under BHP's Environmental Licence for Port Hedland, BHP must, under its Licence conditions 23 (monitoring and management response) and 24 (ambient air quality monitoring):

 - (ii) a monitoring report providing the results of monitoring and any supporting records, information, reports and data as required Licence condition 24 for the ambient air quality monitoring at Taplin St including a comparison of monitoring results against:

 - (B) $30\mu g/m^3$ (as an annual average);

Fugitive dust at the PM10 fraction (<10 μ m in diameter) can be responsible for health issues (Topić and Žitnik 2012). Occupational inhalation of high iron oxide dust concentrations over the long term can lead to benign pneumoconiosis, termed siderosis (BHP Iron Ore, 2007). The crystalline silica present is believed to be carcinogenic towards humans (IARC 1997)";
