1. Meeting of Assembly

The Assembly met at 12.00 noon pursuant to adjournment.

The Speaker took the Chair.

An Acknowledgement of Country and Prayers were read.

2. Speaker's Statement – Hearing Awareness Week

The Speaker, accompanied by Auslan Interpreter Ms Fiona Perry, made a statement to the House regarding Hearing Awareness Week.

3. Petition

Hillview Lifestyle Village – Mr S.J. Price presented a petition from 175 persons requesting the Legislative Assembly reinstate the City of Kalamunda's decision to refuse to grant planning approval for 'proposed hardstand and temporary storage' at Lot 200/584 Kalamunda Road, High Wycombe (P. 63).

6. Civil Liability Legislation Amendment (Child Sexual Abuse Actions) Bill 2017

7. Salaries and Allowances Amendment (Debt and Deficit Remediation) Bill 2017

Schedule indicating the amendments made by the Legislative Council in the Salaries and Allowances Amendment (Debt and Deficit Remediation) Bill 2017

No. 1

Clause 2, page 2, lines 8 and 9 — To delete the lines and substitute:

(b) the rest of the Act — on the day after that day.

No. 2

Clause 9, page 10, lines 11 to 17 — To delete the lines and insert:

- (2) The Tribunal must not make a determination under section 5A, 6 or 7C, or a report under section 7, which
 - (a) has the effect of providing for the payment or provision of remuneration on the basis that the remuneration was not paid or provided before 1 July 2021 by reason of the operation of section 10C, 10D, 10E or 10F (as the case requires); or
 - (b) takes into account any increase in the cost of living that occurred between commencement day and 1 July 2021.
