1. Meeting of Council

The Council assembled at 10.00am pursuant to order.

The President, Hon Alanna Clohesy, took the Chair.

Prayers and an Acknowledgement of Country were read.

2. Petition

Hon Nick Goiran presented a petition from 2,232 petitioners requesting the Legislative Council to urge the Attorney General to release of the Coroner's Court Recommendation to amend the *Health (Miscellaneous Provisions) Act 2011.* (Tabled Paper 792).

5. Early Childhood Sector

7. Climate Change and Greenhouse Gas Emissions Reduction Bill 2021

Non-Government Business No. 1 having been called, Hon Dr Brad Pettitt, pursuant to notice, moved —

That a Bill for "An Act to provide for —

- targets for the reduction of greenhouse gas emissions and the increase in renewable energy generation; and
- the establishment of the Climate Change Council,

and for related purposes." be introduced and read a first time.

Question — put and passed.

Bill read a first time.

Hon Dr Brad Pettitt moved, That the Bill be read a second time.

Hon Dr Brad Pettitt tabled an Explanatory Memorandum relating to the Bill. (Tabled Paper 793). Debate stands adjourned.

8. Climate Change

Non-Government Business No. 2 having been called, Hon Dr Brad Pettitt moved, without notice — That this House notes:

- the Paris Climate Agreement, the latest IPCC reports, other associated climate science, and the implications of their recommendations for addressing climate changes here in Western Australia and across the globe;
- (b) the economic opportunities that an ambitious transition to a low carbon economy creates for Western Australia; and

- (c) that Western Australia is the only Australian state with rising carbon emissions and one of the few Australian states to not have legislated targets for reducing carbon emissions and calls on the Western Australian Government to:
 - (i) develop as a priority (and bring back to this Parliament) a legislated target for reaching net zero carbon emissions and an interim target for 2030 that is consistent with the latest IPCC report and associated climate science; and
 - (ii) set up a climate expert panel to advise Government with transparent and regular reporting mechanisms to the Parliament.

Debate ensued.

Motion lapsed.
