I refer to a newspaper article dated April 6 2002 which appeared on page 9 of *The West Australian* newspaper titled 'Put Alcoa in Court for Leak, Urges Edwardes', a letter dated February 20 2001 addressed to Mr John Shipp, Kalgoorlie Consolidated Gold Mines (KCGM) from the Department of Environmental Protection (DEP) titled 'Quarterly Tailings Storage Facilities (TSF) Monitoring reports, October - December 2000, Mt Percy TSF, Fimiston TSF Gidgi TSF', a letter dated January 9 2001 addressed to Mr John Shipp, General Manager, Kalgoorlie Consolidated Gold Mines from the DEP titled '2000 Operational Audit of the Fimiston I and Fimiston II TSF'S' and all monitoring reports in the last two years required in accordance with licence conditions for the Fimiston, Gidgi and Mt Percy Tailings Storage Facilities -

- (1) In relation to the newspaper article dated April 6 2002 is it correct that the Minister stated 'If they have breached the licence they should be prosecuted and I'd be advocating that ... As long as there is evidence that the leak was a breach of the licence conditions, there is no reason not to prosecute'?
