FRIDAY, 22 NOVEMBER 2019

1. Meeting of Council

The Council assembled at 10.00am pursuant to Temporary Orders.

The President, Hon Kate Doust, took the Chair.

Prayers and an Acknowledgement of Country were read.

2. Royalties for Regions Amendment Bill 2019

Hon Diane Evers: To move on the next day of sitting —

That a Bill for "An Act to amend the *Royalties for Regions Act 2009*." be introduced and read a first time.

3. Suspension of Standing Orders — Business of the House

The Leader of the House moved, without notice —

That so much of the Standing Orders be suspended as to enable the following variations to the order of business and sitting days and times to those agreed by the House on 16 October 2019 until the *Voluntary Assisted Dying Bill 2019* is read a Third Time as follows —

 - (ii) The sitting to be suspended between 12.30pm and 2.00pm
 - (iii) Question Without Notice to be taken at 4.30pm; and
 - (iv) Members' Statements to be taken at 5.00pm.

Hon Nick Goiran, by leave, amended his amendment by deleting "poison" where it occurs and inserting "substance".
