#### 1. Meeting of Council

The Council assembled at 10.00am pursuant to order.

The President, Hon Alanna Clohesy, took the Chair.

Prayers and an Acknowledgement of Country were read.

#### 5. Public Trustee Scale of Fees 2022/23 — Disallowance

Hon Lorna Harper: To move on the next day of sitting —

That, pursuant to recommendation of the Joint Standing Committee on Delegated Legislation, the *Public Trustee Scale of Fees 2022/23* published in the *Gazette* on 17 June 2022 and tabled in the Council on 9 August 2022 under the *Public Trustee Act 1941*, be and is hereby disallowed. (Tabled Paper 1429).

#### 6. City of Fremantle Cat Management Amendment Local Law 2022 — Disallowance

Hon Lorna Harper: To move on the next day of sitting —

That, pursuant to recommendation of the Joint Standing Committee on Delegated Legislation, the *City of Fremantle Cat Management Amendment Local Law 2022* published in the *Gazette* on 1 July 2022 and tabled in the Council on 9 August 2022 under the *Local Government Act 1995*, be and is hereby disallowed. #### 7. City of Joondalup Health Amendment Local Law 2021 — Disallowance

Hon Lorna Harper: To move on the next day of sitting —

That, pursuant to recommendation of the Joint Standing Committee on Delegated Legislation, the *City of Joondalup Health Amendment Local Law 2021* published in the *Gazette* on 5 August 2022 and tabled in the Council on 9 August 2022 under the *Health (Miscellaneous Provisions) Act 1911*, be and is hereby disallowed. (Tabled Paper 1366).

#### 8. Accountability and Transparency

Hon Dr Steve Thomas: To move on the next day of sitting —

That this House notes —

- (a) the Premier's 2017 commitment in Opposition of a "gold standard of transparency" which he has failed to deliver;
- (b) the concerns raised by the Annual Report of the Office of the Auditor General which highlights multiple qualified audit opinions;
- (c) the declining standard of Parliamentary accountability under the McGowan Government;
- (d) the contempt that has crept into the Government in relation to accountability, resulting in a loss of community confidence;

and calls on the Government to try to make a genuine attempt to live up to its 2017 election commitment.

#### 9. Government Infrastructure and Asset Investment

Non-Government Business No. 1 having been called, Hon Dr Steve Thomas moved, without notice —

That this House notes the McGowan Government's mismanagement of its infrastructure and asset investment program despite being gifted the largest budget surpluses in the history of any State Government in our Nation's history as a result of the recent iron ore boom, including —

- (a) the Government's inability to deliver MetroNet on time and on budget;
- (b) the Government's inability to deliver other transport infrastructure;
- (c) the Government's inability to deliver health infrastructure, including long promised election commitments; and
- (d) the Government's inability to deliver other projects, especially in regional Western Australia.

Debate ensued.

Hon Dr Steve Thomas, by leave, tabled a chart detailing the Government's Infrastructure and Asset Investment, *Asset Investment Plan 2014-15 to 2024-25*. (Tabled Paper 1716).

#### 10. TAFE and Training

Private Members' Business No. 1 having been called, Hon Stephen Pratt moved, without notice — That the Legislative Council —

- (a) acknowledges the important role TAFE and training plays in Western Australia to encourage employment and create a skilled workforce; and
- (b) notes that the McGowan Government's significant investment in training, including the reduction of fees for 210 courses by up to 72 percent, the largest TAFE capital works program in the State's history and support for employers has resulted in a record highest ever enrolments.

- (2) The Minister must cause the report to be laid before each House of Parliament as soon as practicable after it is prepared, but not later than 12 months after the 5<sup>th</sup> anniversary.
