#### **LEGISLATIVE COUNCIL**

# **THURSDAY, 23 MARCH 2023 10.00am**

#### 1. Meeting of Council

The Council assembled at 10.00am pursuant to order.

The President, Hon Alanna Clohesy, took the Chair.

Prayers and an Acknowledgement of Country were read.

#### 2. Statement by President — 2023-24 Budget Estimates

The President made the following Statement —

I have received some correspondence that states —

The Standing Committee on Estimates and Financial Operations (Committee) seeks your permission to hold the 2023-24 Budget estimates hearings in the Legislative Council Chamber in the week commencing Monday, 26 June 2023. I acknowledge that the Legislative Council has already resolved to adjourn at its rising on

Thursday, 22 June 2023 to 2:00 pm Tuesday, 8 August 2023 to facilitate the hearings. In the meantime, I ask that you advise the Council of the following arrangements for the Committee's consideration of the 2023-24 Budget estimates:

- (1) The Committee will hold hearings in the week commencing 26 June 2023.
- (2) Members are encouraged to participate in the evidence gathering process by asking questions prior to, during, and after hearings, and by nominating agencies to appear for a hearing.
- (3) The Electronic Lodgement System will open for questions prior to hearing on Thursday, 11 May 2023, with the release of the Budget, and will close at 5pm on Tuesday, 23 May 2023.
- (4) Members may nominate agencies to appear, for the Committee to consider, by 5pm on Tuesday, 16 May 2023.
- (5) The Committee will email Members the Procedure Policy, which will set out the key processes and deadlines, and timetable for hearings once finalised. Although this process is intended to focus on the budget estimates, Members may, within reason, ask general questions about the operations and finances of an agency that are outside the years in question or the budget papers.

#### 4. City of Wanneroo Bush Fire Brigades Local Law 2022 — Disallowance

#### 6. Government Failures — Oversight and Accountability

Non-Government Business No. 1 having been called, Hon Dr Steve Thomas moved, without notice —

That this House condemns the McGowan Government for —

- (a) its failure to deliver proper oversight of its departments and government trading enterprises as evidenced by the unfolding of the biggest scandal our State has seen since WA Inc. at the Perth Mint; and
- (b) its lack of ministerial accountability for its failures.

#### 7. Strong Renewable Energy Economy

Private Members' Business No. 1 having been called, Hon Shelley Payne moved, without notice —
That this House commend the McGowan Government on its commitment towards building a strong renewable energy economy by —

- (a) helping to streamline the Mining Act to reduce administrative burden and supporting best environmental practices to facilitate the extraction of critical minerals for the new mineral economy;
- (b) investing in renewable energy systems across the State including solar, wind, battery and hydrogen; and
- (c) the fast-tracking of green energy projects.
