

**DIVISION 4: PUBLIC SECTOR COMMISSION —**

*[Supplementary Information No A4.]*

*Question:* Mr Z.R.F. Kirkup asked for a breakdown of the agencies where there were matters of minor misconduct complaint made to the Public Sector Commission and the numbers within individual agencies, without revealing any identities or agencies for which there was one complaint that might identify the individual in question.

*Answer:* The table below provides those minor misconduct matters received by the Public Sector Commission in the 2019–20 financial year and broken down by individual entities. Details for entities with fewer than 30 employees by headcount have not been included to prevent possible identification and to maintain confidentiality in smaller entities. Entities with only one minor misconduct matter have been combined to maintain their confidentiality.
