LEADER OF THE OPPOSITION IN THE ASSEMBLY - PARLIAMENTARY QUESTIONS

Statement

HON SANDRA CARR (Agricultural) [5.41 pm]: Given that Parliament resumed this week on Valentine's Day, I feel it would be remiss of me not to share a little story about love. Valentine's Day is a day when lovers traditionally exchange gifts and loving sentiments—at times in cute little notes coyly questioning "Will you be my Valentine?". On the first sitting day this year, Valentine's Day, the women of WA were given a delightful gift in the form of yet another reminder that some in the opposition seem to have a very difficult time valuing and accepting the appointment of women to leadership. On Valentine's Day, in the other place, the newly appointed Leader of the Opposition—the aptly named Hon Shane Love—posed his own little Valentine's Day question.

Hon Dr Steve Thomas: I don't think he is honourable.

Hon SANDRA CARR: I might have elevated his status there! I am feeling a bit generous today. Maybe I was being ironic.

He waxed poetic, asking "Did the member for Bassendean demand that he be replaced by a female member as a condition of his resignation; and, was this the other reason the only working farmer on the ALP benches was held back from being the next Minister for Agriculture and Food?" Allow me to paraphrase his gentle Valentine's Day prose. What the Leader of the Opposition was really asking is: did the new minister only get the job because she is a woman? He asked this with the head-scratching, knuckle-dragging subtext of "Are women holding men back?"

Never mind that Minister Jarvis has been an equal partner in a farming business for more than 25 years, and has an extensive and award-winning career in agribusiness. Never mind that she is best qualified to fulfil the role with extensive relevant industry experience. Yet, even that is beside the point, because if experience in the relevant industry is the Leader of the Opposition's criteria for holding a portfolio, can I remind him that he holds the Shadow portfolios of Transport; Climate Action and other portfolios affecting mining and petroleum?

But like all "Love" stories, this one goes on giving because if we were ever in any doubt that the Leader of the Opposition was indeed questioning whether Minister Jarvis was appointed Minister for Agriculture and Food; Forestry; Small Business—all industries in which she has direct on-the-ground and extensive experience—the Leader of the Opposition confirmed this by dropping a secondary Valentine's Day love bomb by asking a supplementary question. "Arghh so frustrating! It continually amazes me how many men miss the nuance that for hundreds of years, it is highly likely they were only appointed to the roles because they were male, not because they were the best person for the job."

A planning engineer wrote -

"Such a shame that women working in historically male dominated fields still need to justify their skills, experience and capability or face the dreaded (incorrect) assumption of being a diversity hire."
