

FIRE AND EMERGENCY SERVICES — PRESCRIBED BURNS AND BUSHFIRE SUPPRESSION

1266. Hon Dr Brad Pettitt to the Minister for Emergency Services:

- (1) How much did the Department of Fire and Emergency Services (DFES) spend on each of the following in the 2021–22 financial year:
- (a) prescribed burning in the south-west forest regions;
 - (b) bushfire suppression in the south-west forest regions;
 - (c) prescribed burning in each of the other DBCA regions;
 - (d) bushfire suppression in each of the other DBCA regions;
 - (e) prescribed burning in total;
 - (f) bushfire suppression in total;
 - (g) bushfire technical services;
 - (h) bushfire risk management planning;
 - (i) land use planning for the Rural Fire Division;
 - (j) the Bushfire Centre of Excellence; and
 - (k) payments to local government for bushfire mitigation:
 - (i) to each local government; and
 - (ii) in total?
- (2) How much did the state government spend in the 2021–22 financial year on each of the following:
- (a) the State Bushfire Advisory Council;
 - (b) the Interagency Bushfire Operations Committee;
 - (c) the State Emergency Management Committee; and
 - (d) the Office of Bushfire Risk Management?

Hon Stephen Dawson replied:

- (1) (a)–(f) The Department of Fire and Emergency Services (DFES) is unable to determine the costs as requested. DBCA are responsible for fire suppression and mitigation in the State's forests and National Parks.
- (g) \$1,156,734 excluding indirect costs.
 - (h) \$3,470,920 excluding indirect costs.
 - (i) \$623,868 excluding indirect costs.
 - (j) \$5,002,849 excluding indirect costs.
