I refer to youth detention. Can the minister please provide the following information on Banksia Hill Detention Centre and unit 18, respectively, for May 2023 and June 2023 to date —

- (a) the number of suicide and self-harm attempts;
- (b) the monthly average out-of-cell hours; and
- (c) the number of occasions on which a young person spent 20 or more hours in their cell?

Hon STEPHEN DAWSON replied:

I thank the honourable member for some notice of the question. I now represent the Minister for Corrective Services. The information is mainly in tabular form. It is quite a long answer. It lists the number of suicide and self-harm attempts at various dates. It has additional information in terms of definitions et cetera.

Additional information:

Out-of-cell hours are impacted by critical incidents, including damage and behavioural incidents by detainees, as well as detainee movements and arrangements made to facilitate visits, court appearances, and medical appointments. When there are instances of detainees testing positive to COVID this can also impact their out-of-cell hours to maintain appropriate isolation. Further, when a young person declines to exit their cell to engage in the day program, the time spent in cell is recorded as such.
