I have also to express, both personally and on behalf of my fellow managers appointed by this House to attend that Conference, our thanks for the courtesy with which we were treated by the managers for the Legislative Council, who obviously desired to arrive at a settlement. The fact is that both parties, acting in support of what they believed to be essential principles, found themselves at difference as to those principles, and could not have come to an agreement except at the cost of what one side or other would have deemed an undue surrender.
