CESSATION OF NOMINATED IMMIGRATION.

Mr. SHENTON, in accordance with notice, asked the Colonial Secretary, "To "lay on the Table a copy of the corre"spondence between the late Administra"tor and the Home authorities relative "to the cessation of nominated immigra"tion." It was rumoured that His Excellency during the recess had put a stop to that system of introducing immigrants into the Colony, and he thought it was very desirable the House should be placed in possession of the correspondence on the subject.

THE COLONIAL SECRETARY (Hon. M. Fraser) said that the recent correspondence with the Home Government on the subject of immigration would shortly be transmitted to the Council by His Excellency the Governor.
