### QUESTION—SECESSION, COMMON-WEALTH COMMITTEE

Mr. Somerville's Position.

Mr. LATHAM asked the Premier: 1, Is it intended to make a temporary appointment to the Arbitration Court in the absence of Mr. Somerville? 2, Is it intended to continue payment of Mr. Somerville's salary as a member of the Arbitration Court during the time he is in the employment of the Commonwealth Government?

The MINISTER FOR WORKS (for the Premier) replied: 1, Yes. 2, The leave granted Mr. Somerville does not earry with it any obligation regarding payment of salary by the State. There are very few precedents in this State on which to base a decision, but the matter is being enquired into.

# QUESTION—NORTH-WEST, MEDICAL INSPECTION OF CHILDREN.

Mr. LATHAM asked the Minister for Health: Did Dr. Stang receive any portion of a boat fare or other remuneration from the Government on the understanding that school and other children would be medically examined by her in December, 1932?

The MINISTER FOR WORKS (for the Minister for Health) replied: Yes: £6 12s. 6d., being proportion of return fare, Fremantle to Onslow. Owing to circumstances over which Dr. Stang had no control, the actual examination of children proved to be impossible.
