imagine that the Vasse people would not wish to see the whole project abandoned, simply because the line is not brought into that town from this particular spot. When this memorial goes to the Government of course it will be for them to determine whether it would be prudent to insist upon what the memorialists now wish; or whether it would not be better in the interests of that district itself, and of the colony at large, to accept what the company are prepared to carry out? It is simply a question of adopting the views of the memorialists or of abandoning the whole thing.

Motion put, and address agreed to.

The House adjourned at half-past nine o'clock, p.m.

PROROGATION.

HIS EXCELLENCY THE GOVER-NOR shortly afterwards entered the Council Chamber, and delivered the following Speech:—

"Mr. Speaker and Gentlemen of the "Legislative Council,—

"I heartily congratulate you upon the satisfactory completion of the important business which has occasioned this special Session.

"The Constitution Bill which you have "passed will be transmitted by me to the "Right Honorable the Secretary of State "by the out-going mail, and, in addressing Lord Knutsford upon the subject, "it has given me pleasure to express my strong sense of the friendly, conciliatory, "and loyal manner in which Your Hon-"orable House has joined with me in "considering and working out the details of Responsible Government."

"Our labours are ended, and it remains for Her Majesty's Government, and for "the Parliament of the Empire, to do what is still necessary.

"I have but little doubt that the Con"stitution Bill will be returned to the
"Colony with Her Majesty's assent in the
"course of a few months, and that, be"fore the year closes, there will devolve
"upon the Governor the interesting duty
"of summoning to his assistance the first
"Responsible Ministers of Western Aus"tralia.

"You may, meanwhile, be called together for another short Session to consider the new Electoral Bill which, as I
have already informed you, is about to
be prepared.

"I shall ever retain the most pleasaut recollections of our work together in many matters, but particularly in the settlement of the new system of Gov"ernment, to which so many hopes, and "so promising a future, are about to be confided."

"I now prorogue this Council to Tues-"day, the 11th day of June next."

HIS EXCELLENCY, having handed a copy of the Speech to Mr. Speaker, retired from the Council Chamber, and the Session closed.
