RIGHTS OF WAY TO GRANTS SEVERED BY EASTERN RAILWAY.

Goldsworthy) replied as follows:—No general rule can be laid down; each case being considered by itself when the amount to be paid for land taken is under consideration, and the owner informed by the Commissioner of Railways what is intended to be done in respect to right-of-way, when making offer of compensation.

A Bill intituled an Act to impose certain Stamp Duties, was read a first time, on the motion of the Colonial Secretary (Hon. R. T. Goldsworthy).

THIRD READING.

The Masters of Vessels Act, Repeal Bill, 1879, was read a third time and passed.
