# GERALDTON AND NORTHAMPTON RAILWAY.

Message from the Governor-No. 4.

The ACTING SPEAKER announced the receipt of the following Message from His Excellency the Governor:—

The Governor acknowledges the receipt of an Address from your Honorable House, requesting him to introduce a Bill to raise by Loan the necessary sum to carry to completion the works of the Geraldton and Northampton Railway, as recommended by the Select Committee, a copy of whose Report has also been presented to the Governor.

The question will receive immediate consideration, and the Governor's decision will be communicated to you with as little delay as possible.

In the meanwhile the Governor considers it right to point out to your Honorable House that your Select Committee are in error in thinking that the decision of the late Governor to alter the gauge of the Railway from 3ft. to 3ft. 6in., at an additional cost of £480 per mile, was arrived at "previously to the vote for raising a Loan for the construction of the Railway." The Loan Act was passed in July, 1873; the Railway Act in November of the same year; and a reference to the Government Gazette of the 27th January, 1874, will show that down to that date tenders were continued to be invited for the construction of a 3 ft. gauge Railway as originally proposed, and as sanctioned by the Legislative Council. It was at or about the date at which Mr. Palmer's tender was accepted. namely June or July, 1874, that the alteration of the gauge was finally decided upon, and therefore twelve months subsequent to the passing of the Loan Bill; and while, undoubtedly, the Legislative Council should have been informed at its meeting in July, 1874, that the gauge had been altered on the responsibility of the then administration, the Governor believes that, with these dates before you. your Honorable House will hasten to admit that the censure contained in the Report of your Select Committee is uncalled for, and to acquit his predecessor of anything more than an oversight in not taking the earliest available opportunity (namely that afforded by the Session of July, 1874,) of informing the Council that he had sanctioned an alteration which your Honorable House are agreed was in itself advisable and proper.

## GERALDTON AND NORTHAMPTON RAILWAY.

Message from the Governor—No. 4.
In Committee.

The SURVEYOR GENERAL (Hon. M. Fraser) moved that this Council, after receiving the explanation afforded by His Excellency the Governor in his Message, has much pleasure in withdrawing the censure lately passed by it upon the late administration of the colony in the second paragraph of the report on the Geraldton and Northampton railway.

After some debate,

Mr. RANDELL moved, as an amendment, that the following words be added to the above motion in so far as in paragraph No. 2, line six from the top, these words occur: "that previously to the vote for raising a loan for the construction of the railway a change of gauge had been determined upon."

Mr. BROWN moved, as an amendment to the original question, that all words after the word "That" be struck out, and the following inserted in lieu thereof: "This Council has much pleasure in finding, from the explanation which His Excellency The Governor in his Message, No. 4, has afforded, that it was in error in concluding that the change of gauge from three feet to three feet six inches had been determined upon previously to the

vote for raising the Loan for the construction of the Railway in 1873, and it therefore withdraws the charge of want of candor made by it in consequence against the late administration. The Council, however, regrets to find that the Executive Government, in informing the Council during the Session of 1874 that the contract had been accepted, when, at any rate, they had determined on the change, did not make the Council acquainted with the fact and ask for the increased note necessary to carry it out, and think that such reticence under such circumstances, evidenced a want of consideration of the views and province of the Legislative Council."

Question, that the amendment moved by Mr. Brown be agreed to, put and passed.

The Council adjourned at 5 p.m.
