2               This is the *Appropriation (Capital 2017-18) Supplementary*  
3               *Act 2018*.

4   **2.       Commencement**

5               This Act comes into operation as follows —

6               (a)   sections 1 and 2 — on the day on which this Act  
7               receives the Royal Assent;

8               (b)   the rest of the Act — on the day after that day.

9   **3.       Appropriation for capital purposes**

10              The sum of \$38 695 867, being payments of an extraordinary or  
11              unforeseen nature made for the year ended 30 June 2018 under  
12              the authority of the *Financial Management Act 2006* and  
13              charged to the Consolidated Account under that Act, is  
14              appropriated for the capital purposes expressed in Schedule 1.
