An Act to amend the *Local Government Act 1995*, the *Local Government (Miscellaneous Provisions) Act 1960* and certain other Acts.

The Parliament of Western Australia enacts as follows:

Part 1 — Preliminary

1. Short title

This is the *Local Government Legislation Amendment Act 2019*.

2. Commencement

This Act comes into operation as follows —

- (a) Part 1 — on the day on which this Act receives the Royal Assent (*assent day*);
- (b) sections 5, 13 to 17, 20, 24, 25 to 44, 48 to 51, 57, 61, 64 to 68, 74 and Part 4 — on a day fixed by proclamation, and different days may be fixed for different provisions;
- (c) the rest of the Act — on the day after assent day.
