Kobelke, MLA, Chairman of the Public Accounts Committee, advising that the Committee had determined for itself terms of reference in relation to an Inquiry into the Implications of the New Structure and Functions of the Department of the Premier and Cabinet and the Public Sector Commission.

The letter read as follows –

"

Dear Mr Speaker,

The Public Accounts Committee today resolved to initiate a new Inquiry into the Implications of the New Structure and Functions of the Department of the Premier and Cabinet and the Public Sector Commission. The terms of reference for the inquiry are:

That the Committee will examine and report on:

- 1. The implications of the new structure and functions of the Department of the Premier and Cabinet and the Public Sector Commission and the adequacy of the *Public Sector Management Act 1994* and other statutes to provide for these changes; and
- 2. The implications of a more timely and efficient government Chief Executive Officer appointment process.
- 3. The Committee will table the Inquiry's report on Thursday, 11 June 2009.

".

6. Community Development and Justice Standing Committee – Terms of Reference

The Speaker advised members that he had received a letter dated 11 December 2008 from Ms A.J.G. MacTiernan, MLA, Chairman of the Community Development and Justice Standing Committee, advising that the Committee had determined for itself terms of reference in relation to an Inquiry into the Adequacy of Services to Meet the Developmental Needs of Western Australia's Children

The letter read as follows –

Dear Mr Speaker,

The Community Development and Justice Standing Committee today resolved to initiate a new Inquiry into the Adequacy of Services to Meet the Developmental Needs of Western Australia's Children. The terms of reference for the inquiry are:

That the Committee will examine and report by 31 July 2009 on:

- (a) whether existing Government programs are adequately addressing the social and cognitive developmental needs of children, with particular reference to prenatal to 3 years;
- (b) how to appropriately identify developmentally vulnerable children;
- (c) which Government agency or agencies should have coordinating and resourcing responsibility for the identification and delivery of assistance to 0–3 year old children;
- (d) what is the best model to ensure interagency and intergovernmental integration of developmental programs delivered to 0–3 year old children;
- (e) how to best prioritise the resources available for meeting the needs identified;
- (f) what is the most appropriate measure of program outcomes; and
- (g) any other related matter deemed relevant by the Committee.

8. Petitions

McGowan presented a petition from 64 persons requesting that the Legislative Assembly endorse the continued future of the Rockingham Police and Citizens' Youth Club and ensure that sufficient resources and funding are allocated to enable that to occur (P. 43).

Police and Citizens' Youth Club – Mr P.B. Watson presented a petition from 63 persons requesting that the Legislative Assembly endorse the continued future of the Albany Police and Citizens' Youth Club and ensure that sufficient resources and funding are allocated to enable that to occur (P. 44).

9. Matter of Public Interest - Government's Plans for the Health System

At least five members having risen in support,

Mr E.S. Ripper moved,

That the House call upon the Barnett Government to reveal its plans for the future of our health system and in particular:

- (a) Joondalup Health Campus;
- (b) Midland Hospital;
- (c) Albany Hospital;
- (d) Fiona Stanley Hospital; and
- (e) the new Children's Hospital.

Debate ensued.

Question put and passed.

Schedule indicating the amendment made by the Legislative Council in the Sentencing Legislation (Transitional Provisions) Amendment Bill 2008

No. 1

Clause 4, page 3, after line 9 — To insert —

(4) A court sentencing an offender to a fixed term can impose a penalty up to the statutory penalty for the offence.
