4. Culture and the Arts Funding

Motion No. 1 having been called, debate resumed on the amendment of the Minister for Mental Health representing the Minister for Culture and the Arts as follows -

President's Ruling

The President ruled as follows -

On the last occasion the House debated this motion, the Leader of the Opposition asked whether the proposed amendment moved by the Minister for Mental Health was a direct negative and thereby against Standing Orders. Firstly, I note that there is no Standing Order regarding direct negative amendments. Secondly, there have been few rulings in this House relating to direct negative amendments. On the last two occasions on which rulings were given, the substance of the ruling has been that the test is whether the amendment has the same effect as voting against the motion, and an amendment that is simply a positive reframe of the issue is not a direct negative.

The practice in the House of Commons, as in many other Australian Parliaments, is to allow significant latitude for amendments to motions. Amendments are permissible even when they effectively evade an expression of opinion on the main question by entirely altering the question's meaning and intent. An example of such permissible amendments are those that propose the omission of all or most words of the question after the word "that" and substitute an alternative proposition that must, however, be relevant to the subject of the question. It is not in order to move the omission of all words of a question without inserting an alternative question. Similarly, to delete all words after the word "that" and not insert other words would also be interpreted as out of order.

The motion before the House calls on the Government to increase funding for culture and the arts to compensate for reductions made in the 2009-10 and 2010-11 budgets. The proposed amendment seeks to replace the motion with an entirely new question; namely, that this House applauds the Government for increasing funding to culture and the arts in the 2011–12 Budget. In my view, the proposed amendment is a permissible alternative proposition. The proposed amendment is relevant to the subject matter of the original motion and seeks to reflect changes in the Government's funding for culture and the arts since notice of the original motion was given. I rule that the proposed amendment is not a direct negative and is in order.

Debate resumed.

The Minister for Mental Health representing the Minister for Culture and the Arts, by leave, made a personal statement [SO 85] with respect to her amendment to the motion.

Amendment - put and passed.

Debate resumed on the motion, as amended.

Hon Ken Travers, pursuant to notice, moved Motion No. 2 as amended -

That this House condemns the Barnett/Grylls Government for the savage increases in household fees and charges and the abolition of assistance payments to families such as the \$400 "It pays to learn allowance" which has resulted in families being up to \$1700 worse off.

We note that the savage 57 percent increase in electricity and 46 percent increase in water charges over two years has resulted in an increase in the dividends the State Government is receiving from the power and water utilities.

We say enough is enough and call on the Barnett/Grylls Government to keep future increases to below the rate of inflation.
