1. Meeting of Assembly

The Assembly met at 9.00 a.m. pursuant to adjournment.

The Speaker took the Chair.

Prayers were read.

2. Petitions

Transport Services for Patients Undergoing Cancer Treatment – Mr P. Papalia presented a petition from 601 persons requesting that Legislative Assembly consider the implementation of a dedicated transport service for cancer patients in the Rockingham, Singleton, Golden Bay and Secret Harbour areas undergoing treatment in major Perth hospitals (P. 35).

Pedestrian Railway Crossing Upgrade at Bibra Lake – Mr J.M. Francis presented a petition from 198 persons requesting that the Legislative Assembly support the upgrade of the pedestrian railway crossing from a 'passive' to an 'active' one at Prout Way and Little Rush Close, Bibra Lake (P. 36).

Children's Crossing at Pacific Way and Gradient Way Beldon – Ms M.M. Quirk presented a petition from 467 persons requesting that Legislative Assembly maintain the current 'A' warrant status at Pacific Way and Gradient Way Beldon for the protection of children attending Beldon Primary School (P. 37).

Democratic Republic of Congo – Mr W.J. Johnston presented a petition from 4 persons requesting that the Legislative Assembly note the concerns of the Congolese Community of Western Australia about the war in the eastern part of the Democratic Republic of Congo and support the Congolese Community in their efforts to stop the war in Congo (P. 38).

Cockburn Central Railway Station Car Parking Facilities – Mr F.M. Papalia presented a petition from 29 persons requesting that the Legislative Assembly endorse the continued future of the Rockingham Police and Citizens' Youth Club and ensure that sufficient resources and funding are allocated to enable that to occur (P. 41).
