Multi-Purpose Sporting Stadium – Mr J.E. McGrath presented a petition from 8,832 persons requesting that the Legislative Assembly reinstate the requirement of a dedicated rectangular stadium to the proposal to upgrade major stadiums in our State (P. 8).

Residential Parks (Long Stay Tenants) Act 2006 – Mr P.T. Miles presented a petition from 225 persons requesting that the Legislative Assembly promptly review the *Residential Parks (Long Stay Tenants) Act 2006* and consider necessary amendments and the release of land which will allow the Park Home dwellers to resettle (P. 9).

Sealing Roads between Newman, Nullagine and Marble Bar – Mr T.G. Stephens presented a petition from 737 persons requesting that the Legislative Assembly ensure that the Minister for Planning takes the steps needed to give inland towns basic infrastructure such as sealed roads (P. 10).
