### **TUESDAY, 28 NOVEMBER 2017**

#### 1. Meeting of Council

The Council assembled at 2.00pm pursuant to order.

The President, Hon Kate Doust, took the Chair and read prayers.

#### 2. Message from Her Excellency the Governor — Assent to Bill

The President reported the receipt of a Message from Her Excellency the Governor assenting to the following Bills —

#### 3. President's Ruling — Correction of Answers

The President ruled as follows —

On 9 November 2017 at the conclusion of question time, Hon Martin Aldridge raised a point of order about a further answer given by the Leader of the House to question without notice 770. He has asked me to rule on whether the further answer provided conforms to the standards expected of this House.

I refer Members to my ruling about the answering of questions by Ministers given two days earlier. I reiterate that it is not the Chair's responsibility to tell Ministers how they should respond to questions provided that an answer is within the Standing Orders. It is also not the Presiding Officer's role to determine whether an answer is correct. Therefore, there is no point of order. There are, however, certain courtesies that Members usually observe when providing answers that correct information in earlier answers. These are set out in a statement made by President House on Tuesday, 22 March 2016 when he said, and I quote —

When it is discovered that an answer given in any capacity is inaccurate, the Minister or Parliamentary Secretary has an obligation to correct the record at the earliest opportunity, and the usual practice is to also apologise to the House for the error.

The obligation on Members to correct inaccurate answers is to ensure that they do not mislead the House. The deliberate provision of false information to the House would constitute a grave contempt. To avoid any suggestion that such a contempt has occurred, a Member will usually correct inaccurate answers at the earliest opportunity. They will usually also apologise to the House for the error because regardless of in what capacity the answer is given, they are personally responsible for it.

For the benefit of Members, I table two extracts from *Hansard* of corrections to answers; one from this House and one from the other place, that demonstrate the usual courtesies. (Tabled Paper 869).

#### 4. Statement by President — Standing Order 21 — Speaking Times

The President made the following Statement —

Standing Order 21 restricts the majority of Members' speaking time on most matters to 45 minutes. The following three categories of Members, however, have unlimited time to speak on the second and third readings of Bills, the Budget debate and Address-in-Reply. Firstly, the mover of the question and the mover in reply; secondly, the lead Member from the Government or opposition; and, thirdly, each party leader or Member deputised.

In category 1, the unlimited speaking time for the mover of a question and in reply reflects longstanding tradition. The extension of unlimited speaking time to all party leaders in category 3 has applied since 2012. This was a concession arising from increased party representation in the Legislative Council. A party leader may also effectively transfer their unlimited speaking time to another Member of their party for a specific debate by deputising the Member. A Member so deputised must announce the arrangement at the commencement of their speech to ensure that the House is aware of the swap. A question has arisen on the proper interpretation of a lead Member for the opposition for the purposes of category 2. A government lead Member on any particular matter is straightforward. It is a member of the party or parties that support and form the Government and is usually the Minister or Parliamentary Secretary with primary portfolio responsibility in the relevant area. If the lead Member is not also the Leader of the Government, the Government may have two speakers with unlimited speaking time applying to the particular items of business set out in Standing Order 21.

The ordinary parliamentary meaning of "opposition" is Her Majesty's most loyal opposition. This expression is usually shortened to the official opposition. This is the party in opposition with a membership in the House of Government greater than any other non-government party. Currently, this is the Liberal Party. The preference given to the official opposition for unlimited speaking times in Standing Order 21 reflects the fact that the official opposition is the alternative Government. Therefore, the lead Member to speak for the opposition, usually the shadow Minister, has an equivalent speaking time to the government's lead Member. The issue is whether this definition of "opposition lead Member" continues to be appropriate, particularly when, as now, six non-government parties hold seats in this House.

In a recent debate a Member of the Greens WA was given unlimited time as the party's lead Member on the second reading debate on a Bill. I note that on occasion during the thirty-ninth Parliament, Members of the Greens and the National Party were also granted unlimited time after identifying themselves as the lead speakers for their party and not being the party leader or a deputised Member. At the time, the absence of a designated party leader for the Greens caused difficulties in identifying whether a speaker for the Greens was allocated unlimited time. The Standing Committee on Procedure and Privileges has considered the matter after obtaining comments from all parties. The committee does not believe that any amendment is necessary to Standing Order 21. The committee is opposed to an interpretation of "opposition" in Standing Order 21 that would encompass all parties that do not support the Government. Given the current composition of the House, such an interpretation would result in up to 12 Members enjoying unlimited speaking time. If the traditional meaning of "opposition" is applied, this would be restricted to a maximum of nine Members. The committee was of the view that the potential for one-third of all Members having unlimited speaking time would undermine the purpose of Standing Order 21 to limit the length of debates. Accordingly, the committee considers that Standing Order 21 should be strictly interpreted so that only the Labor Party, as the Government, and the Liberal Party, as the official opposition, each have a lead Member. All parties will continue to have a party leader or deputised Member with unlimited speaking time.

I accept the Standing Committee on Procedure and Privileges' advice on this matter and indicate that I shall be applying its recommended interpretation of Standing Order 21 from this point onwards.

# 5. Statement by President — Joint Standing Committee on the Corruption and Crime Commission

The President made the following Statement —

Dear Madam President

Joint Standing Committee on the Corruption and Crime Commission Terms of Reference

The Joint Standing Committee on the Corruption and Crime Commission has today resolved to conduct an inquiry with the following terms of reference:

An inquiry into public sector procurement of goods and services and its vulnerability to corrupt practice

The Committee will examine —

- The adequacy and nature of oversight mechanisms, policies and guidelines for procurement within the WA public sector to prevent corruption and serious misconduct;
- 2. The profile and training of public sector personnel engaged in procurement;
- 3. Corruption prevention and risk strategies deployed in WA Public Sector agencies;
- 4. The sufficiency and use of sanctions for individuals found to have engaged in corrupt and serious misconduct in procurement duties;
- 5. Best corruption prevention practices in procurement from other jurisdictions;
- 6. Reform to current legal and administrative practices in the area of procurement to prevent and reduce the risk of corruption;
- 7. Adequacy of whistle blowing protections in the context of allegations of corruption in procurement.

The Committee will report by April 2019.

- (5) For the purposes of (3)(b):
  - (a) A request by the leader or deputy leader of a party in the Council shall be deemed to be a request by every member of that party who is a member of the Council.
  - (b) A request may be made to the President by delivery to the Clerk, who shall immediately notify the President.
  - (c) If the President is unavailable, the Clerk shall notify the Deputy President, or, should the Deputy President be unavailable, any one of the Deputy Chairs of Committees, who shall be required to summon the Council on behalf of the President, in accordance with this temporary order.

The President having counted the Council, and there being an absolute majority present, and no dissentient voice, declared the motion carried with the concurrence of an absolute majority.
