 - (xi) do these hospitals have free television access in communal areas which can be accessed by mobile patients who cannot afford to pay for television hire (please list answer by hospital)?

- (b) will the same weight be given to submissions opposing forced amalgamations in the metropolitan area?

3029. Mr D.A. Templeman to the Minister for Local Government:

I refer to the government's process of local government amalgamations in the metropolitan area, and the recent denial of a merger of four regional councils by the Local Government Advisory Board (LGAB), and ask:

- (a) why were these councils denied a merger that they have been collaboratively working towards for two years; and
- (b) if willing councils are deemed unsuitable for amalgamation why are you pursuing the amalgamation of unwilling metropolitan councils?

3030. Mrs M.H. Roberts to the Minister for Planning:

I refer to the election commitment to make land available in the Midland Railway Workshop Precinct for lease at a peppercorn rent and a \$22 million commitment for construction of a university campus to house up to 600 students and staff, and ask:

- (a) has an exact location and land been selected;
- (b) if so, where is the land located and what is the size of the site;
- (c) what steps have the Metropolitan Redevelopment Authority taken to sign a lease agreement with Curtin University; and
- (d) when is construction of the new campus expected to start?

3031. Mr P. Papalia to the Minister for Corrective Services:

I refer to the death of a prisoner following a bashing at Wooroloo prison on 21 April 2014 and the fact that charges have been laid against another prisoner, while noting the Minister is unable to prejudice the case before the courts, and I ask:

(a) can the Minister confirm that Wooroloo prison management had previously assessed the prisoner charged over this matter as a higher risk than minimum and had requested his transfer to a medium security prison; and

(b) can the Minister also confirm that the prison management's request for the transfer was denied by the Department's Head Office due to lack of space in medium security prisons?

3032. Dr A.D. Buti to the Minister representing the Minister for Education:

I refer to an article in *The Western Australian* on 9 June 2014, entitled *More schools to merge, close* in which it is reported that "the State Government recently revealed plans to close or merge small schools in the Fremantle and Armadale areas", and I ask:

- (a) can the Minister confirm that you are indeed going to close or merge schools in Armadale and if yes, which schools will the Minister be closing and merging; and
- (b) has the State government produced a business and educational case for the closure and or merger and if so when will this be released to the Armadale Community?

3033. Mr R.H. Cook to the Minister for Health:

I refer to the private operation contract for the Peel Hospital and the requirement that the Government must give notice to the private operator by June 2014 that it will be seeking to renegotiate the contract which comes to an end in 2017, and I ask:

- (a) did the Government give formal notice to Ramsay under the contract to formally renegotiate the contract, and if so when was notice given; and
- (b) was that formal notice preceded by a public sector comparator for the renewal of the contract, and if not, why not?

I refer to the closure of the Workforce Development Centre in Mandurah last year and the Minister's comments in the 2014 Estimates Process to the questions I raised about this matter and ask:

- (a) has the Minister or his Department finalised a Business Case for a new Peel Workforce Development Centre;
- (b) if so when will the Minister be making a decision about reinstating a Workforce Development Centre to the Peel Region; and
- (c) if a Business Case has not been completed when is a decision expected on whether or not the Peel Region is to have such a Centre reinstated?

- (1) Can the Minister please provide an outline of all tenancies for Government departments, agencies or authorities in the city of Karratha, detailing:
 - (a) the Department, agency or authority occupying the space;
 - (b) the size of the office space;
 - (c) the rent paid per square metre;
 - (d) the address of the tenancy; and
 - (e) the date of expiry of the lease?
- (2) Is the department or Minister aware of any tenancies of government departments, agencies or authorities in Karratha that are not managed by the Department of Finance?
- (3) If yes to (2) which organisations are they?

Can the Premier please provide the breakdown of all approved Lotterywest grants by date, recipient, purpose, amount and suburb for each of the following financial years:

- (a) 2011–2012;

- (c) 2013–2014?

3038. Ms R. Saffioti to the Premier:

- (1) Since 30 June 2013, who were the Members whose Electorate Offices were relocated to a new premises?
- (2) In each instance, with respect to the vacated office what was:
 - (a) the old electorate office address;
 - (b) the leased floor area;
 - (c) the annual leasing costs, including all outgoings;
 - (d) the period remaining on this lease; and
 - (e) any lease penalty or costs in quitting the lease?
- (3) In each instance, with respect to the vacated office what is:
 - (a) the new electorate office address;
 - (b) the leased floor area;
 - (c) the annual leasing costs, including all outgoings;
 - (d) the fit-out costs; and
 - (e) the removal costs incurred with the relocation?
- (4) In each instance, what was the reason for relocating the electorate office?

3039. Ms R. Saffioti to the Minister for Sport and Recreation:

Can the Minister provide the breakdown of all approved Department of Sport and Recreation grants by date, recipient, purpose, amount and suburb and grant type for the:

- (a) 2011–2012 period;
- (b) 2012–2013 period; and
- (c) 2013–2014 period?
