#### 1. Meeting of Assembly

- " The Committee resolved the following terms of reference -
  - That this Committee examine, report and make recommendations on the way in which the critical policy, organisational, and practice structures optimally promote sustainable collaborative approaches and activities across government with particular reference to community services and to -
    - (1) networked models of partnerships between public (including local government) and private actors for the development of policy and the delivery of services, with particular emphasis on human service and community development;
    - (2) a review of relevant past government reforms and outcomes in Western Australian, Australian, North American and European public sectors;
    - (3) the role of relevant legislation, economic instruments (e.g. grants), information, direct intervention, in facilitating joined up government;
    - (4) the use of citizen centred services how the Australian and cited overseas jurisdictions are transforming and integrating government processes around the needs of the citizens; and
    - (5) any other relevant issue.

The Committee will report to the Legislative Assembly by 27 November 2008. ".

The Speaker advised that he had arranged for the Committee's terms of reference to be placed on the notice boards of the Legislative Assembly.
