- prohibiting registered lobbyists from agreeing to receive payments or other rewards that are dependent on the outcome of lobbying activities,

and for related purposes." be introduced and read a first time.

That this House condemns the Premier and the Liberal/National Government for leading this State into deficit for the first time in 15 years due to wasteful spending and the mismanagement of the State's finances.

Ms J. Farrer, pursuant to notice, moved, That so much of the Standing Orders be suspended as is necessary to enable the following motion to be moved forthwith –

That the *Constitution Amendment (Recognition of Aboriginal People) Bill 2014* be immediately referred to a Select Committee of six members for consideration and report by 26 March 2015.

Debate ensued.

Question put and passed.

# 23. Referral of Bill to Select Committee

Ms J. Farrer, pursuant to the foregoing motion, moved,

That the *Constitution Amendment (Recognition of Aboriginal People) Bill 2014* be immediately referred to a Select Committee of six members for consideration and report by 26 March 2015.

The Deputy Premier moved, To delete all words after "That" and insert –

- (1) A Joint Select Committee of the Legislative Assembly and Legislative Council be established to consider and report on the appropriate wording to recognise Aboriginal people in the constitution of Western Australia.
- (2) That the Joint Select Committee consist of seven members:
  - (a) three will be members of the Council; and
  - (b) four will be members of the Assembly;

and of those seven members:

- (c) two will be members of the Liberal Party;
- (d) two will be members of the National Party; and
- (e) three will be members of the Australian Labor Party.
- (3) The Standing Orders of the Legislative Assembly relating to Standing and Select Committees will be followed as far as they can be applied.
- (4) That the Joint Select Committee report to both Houses by 26 March 2015.
- (5) That the Legislative Council be requested to agree to a similar resolution.

- (6) That, subject to the Legislative Council agreeing to the above paragraphs, the following Legislative Assembly members be appointed:
  - (a) the Member for Kimberley;
  - (b) the Member for Victoria Park;
  - (c) the Member for Murray-Wellington; and
  - (d) the Member for Kalgoorlie.

Debate ensued.

Amendment put and passed.

On the question, That the motion, as amended, be agreed to,

Question put and passed and the Legislative Council acquainted accordingly.

# 24. Polling on Council Amalgamation Processes

Mr D.A. Templeman, pursuant to notice, moved,

That this House:

- (a) condemns the Premier and the Minister for Local Government for allowing, through its forced amalgamation process, some communities in the metropolitan area an opportunity to have a poll under the Dadour Provisions in the *Local Government Act* 1995 about their local council's future, while others have not been given that democratic right; and
- (b) further supports all affected communities having a right to a poll on their council's future.

Debate ensued.

Debate interrupted by the Chair (Minister for Local Government speaking) and adjourned until a later stage of the sitting.

# 25. Message from the Governor

Message No. 26 from Her Excellency the Governor was reported recommending that appropriations be made for the purposes of the Integrity (Lobbyists) Bill 2014.
