**3192. Ms M.M. Quirk to the Minister for Transport:**

I refer to a proposal to construct commercial premises at 601 Wanneroo Road, Hamersley (DA14/2483) and consequent proposed changes to the road alignment to accommodate that development, and I ask:

- (a) what will the effect be of the roundabout planned on the intersection of Wanneroo and Camberwell Roads Hamersley/Balga;
- (b) what is the number of deaths and serious injuries at this intersection for the last four financial years;
- (c) what are the current vehicle counts for each hour of the week;
- (d) what are the average vehicle speeds at this intersection;
- (e) what is the predicted increase in the crash rate through the use of a roundabout on this main road at that location; and
- (f) what is the predicted time take to get around this intersection both for Northbound as well as Southbound on Wanneroo Rd with a roundabout?

**3193. Ms M.M. Quirk to the Minister for Environment:**

I refer to a proposal to construct commercial premises at 601 Wanneroo Road, Hamersley (DA14/2483) and I ask, given that the proposed development is on part of the land operated by Commonwealth Department of Communications, Broadcast Australia Pty Ltd or the ABC, does the Western Australian *Environmental Protection Act 1986* apply fully to that site?

**3194. Mr D.A. Templeman to the Minister representing the Minister for Education:**

I refer to the Minister's recent announcement that expressions of interest will be advertised under a public/private partnership for the construction of a number of schools in Western Australia, including a proposed Secondary School at Lakelands in Mandurah and ask:

- (a) what year is the Lakelands High School expected to commence construction;
- (b) when is this proposed school expected to open;

- (c) what years will the Lakelands High School cater for;
- (d) will a Secondary Education Support Centre be included in this new school;
- (e) if yes to (d), what years will be catered for in this Education Support Centre;
- (f) what is the expected enrolment for the opening of this proposed Secondary School;
- (g) what is the expected catchment for this new Secondary School;
- (h) what effect will this new school have on future enrolments at John Tonkin College in Mandurah;
- (i) will the construction of this new school see the closure of the John Tonkin College Campus at Tindale Street in Mandurah (Old Mandurah High School Site);
- (j) what effect will this new school have on future enrolments at Coodanup Community College; and
- (k) what planning processes were undertaken to determine the need for a new Secondary school at Lakelands in the timeframe outlined by the Minister's recent announcement?

**3195. Mr B.S. Wyatt to the Minister for Housing:**

I refer to the subsection 72(2) of the *Residential Tenancies Act*, which provides the Department of Housing (the Department) with the means to offer Fixed Term Public Housing Tenancy Agreements, and Termination of these agreements by the Department of Housing Without Grounds, and I ask:

- (a) could the Minister please provide details of the gender of each person offered a Fixed Term Tenancy Agreement by the Department over the last three years;
- (b) could the Minister please provide details of the age of each person offered a Fixed Term Tenancy Agreement by the Department over the last three years;
- (c) could the Minister please provide details of the number of Indigenous clients offered a Fixed Term Tenancy Agreement by the Department over the last three years, as well as what percentage this comprised of the entire amount of Fixed Term Agreements offered by the Department over this period;
- (d) how many Fixed Term Tenancy Agreements has the Department offered each year, for the last three years;
- (e) of all of the Fixed Term Tenancy Agreements offered by the Department over the last three years, how many were offered to new tenants not previously housed by the Department of Housing;
- (f) under what circumstances does the Department offer Fixed Term Tenancy Agreements;
- (g) under what circumstances does the Department terminate Fixed Term Tenancy Agreements at the end of the fixed term period; and
- (h) is there a written policy governing the use of Fixed Term Tenancy Agreements by the Department, and if so, where can that policy be found?

  - (a) the Kimberley;
  - (b) Perth metropolitan area; and
  - (c) state wide?

- (1) How many children currently in the care of the CEO of the Department of Child Protection are students at each of the Primary Schools located in Broome?
- (2) How many children subject to child protection notifications in the last 12 months are students at each of the primary schools located in Broome?
- (3) What is the average proportion of students in Western Australian primary schools state wide that are in the care of the CEO of the Department of Child Protection?
- (4) What is the average proportion of students in Western Australian primary schools state wide that are subject to child protection notifications?

**3198. Ms J. Farrer to the Minister representing the Minister for Education:**

I refer to the State Government's planning and establishment of Child and Parent Centres in Western Australia and I ask:

- (a) was consideration given to the establishment of a Child and Parent Centre in Broome;
- (b) if yes to (a), can the Minister advise if a planning report was prepared into the feasibility of a Child and Parent Centre in Broome, and if so can the Minister table a copy of the report;
- (c) if no to (a), why was Broome not considered as a site for a Child and Parent Centre; and
- (d) for what reason did the State Government determine that the Kimberley should not receive a Child and Parent Centre?

**3199. Ms J. Farrer to the Minister representing the Minister for Education:**

- (1) Have any Primary Behaviour Centres been established at any Primary Schools in the Kimberley?
- (2) If yes to (1), what is the location of each centre?
- (3) If no to (1), why are there no Primary Behaviour Centres in the Kimberley?
- (4) If yes to (1), is there a waiting list for a child to be enrolled in a Primary Behaviour centre?
- (5) If yes to (4), what has been the average waiting time for enrolment in each of the past five years for each centre?
- (6) If yes to (1), have any resources been cut from any centre due to the State Government's education funding cuts?
- (7) If yes to (6), what are the details of all cuts to all centres?
