Question No. 1: Hon Alanna Clohesy MLC asked -

I refer to page 36 of the Annual Report, "Goldfields Arts Centre upgrade", and ask-

- (a) Is there a business plan for Stage 2 of the implementation of the Goldfields Arts Centre upgrade?
- (b) If yes, could the Department table this plan please?
- (c) If no, are there any plans for Stage 2 in development and what funding has been allocated?

Answer:

(a-c) Cabinet approved an allocation of \$6.2 million to the Goldfields Arts Centre project, \$5 million for capital upgrades and \$300 000 per annum over four years for operational costs.

The Department of Culture and the Arts has an advisory role with regard to investment of the funding for Goldfields Arts Centre; the facility is owned by the Department of Training and Workforce Development which has a management arrangement in place with the City of Kalgoorlie-Boulder.

Question No. 2: Hon Alanna Clohesy MLC asked -

I refer to page 17 of the Annual Report, "Partnerships with key stakeholders", - The Australia Council recently announced significant changes to its funding model. In particular, new six-year funding contracts have been announced. How is the Department responding to these changes?

Answer:

The Australia Council is yet to announce the administrative arrangements to support the new funding model. When these are released the Department of Culture and the Arts will liaise with the Australia Council to discuss issues such as selection criteria for organisations, how the peer process will be applied, and how states and territories will be involved to ensure that investment is made equitably across states and art-forms. The Department will then consider if any changes to its policies or processes are required.

Question No. 3: Hon Alanna Clohesy MLC asked -

I refer to page 18 of the Annual Report, "Stakeholders, Commonwealth Government Ministry for the Arts"-

The DCA continued to work with the Commonwealth Government's Ministry of the Arts to facilitate the development of Aboriginal Art Centres across WA through a professional development program delivered both in Perth and onsite at each art centre.

(a) Which Aboriginal Arts Centres participated in this program?

Answer:

Waringarri Aboriginal Arts, Martumili Artists, Mowanjum Art and Cultural Centre, Roebourne Art Group, Tjarlirli Art, Tjukurba Art Gallery, Warakurna Artists, Wirnda Barna Artists, Yamaji Art, Yarliyil Art Centre, Bidyadanga Artists, Gwoonwardu Mia Cultural Centre, Maruku Arts, Spinifex Hill Artists and Mangakaja Arts

(b) What is the cost of the implementation of this program?

Answer:

The total project budget for professional development is \$147 000.

This figure combines contribution of \$107 000 from the Australian Government and \$40 000 from the State Government.

(c) How is this program evaluated?

Answer:

The program is evaluated by an independent consultant.

Question No. 4: Hon Kate Doust MLC asked -

I refer to page 91 of the Annual Report and this statement - "Land and buildings are independently valued annually by the Western Australian Land Information Authority (Valuation Services) ... "and ask -

(a) Is the Yirra Yaakin Theatre (0.0852ha) at 65 Murray Street, Perth owned by the Department?

Answer:

No

(b) If no to (a), what agency does own the property?

Answer:

 - *i.* When was the site last valued and at what price was it valued?
 - ii What is the site's current zoning?
 - iii. Have contamination issues been identified for this site and, if so, what are they?

Question No. 5: Hon Lynne McLaren MLC asked -

I refer to "Statement of comprehensive income" on page 81 of the Annual Report. Please breakdown how employees benefits expense dropped from \$49 283 000 to \$14 339 000 from 2013-14?

Answer:

The decrease in Employee Benefits Expenses from \$49 283 000 to \$14 339 000 in 2013-14 is due to the Machinery of Government Change effective from 1 July 2013 as disclosed in Notes 6 and 7 on page 103.

"Note 6. Machinery of Government Change

Effective from 1 July 2013, the Culture and the Arts portfolio arrangements were adjusted to return employing authority to the relevant statutory bodies (by delegation from the Director General), along with budget appropriation for salaries.

The statutory authorities are:

- Art Gallery of Western Australia
- Western Australian Museum
- Perth Theatre Trust
- State Library of Western Australia

This has the following impact:

(a) Employee benefits which were previously appropriated to the Department of Culture and the Arts are now being appropriated direct to the statutory authorities. This has resulted in a reduction in both employee benefits expenses and service appropriation.

Employment on -costs liability is included at note 28 'Provisions'.

Question No. 6: Hon Lynne McLaren MLC asked -

I refer to "Statement of income and expenses by services" on page 85 of the Annual Report, and ask –

(a) If services provided to external agencies is significantly less, who is taking on the work load to provide corporate services within the Culture and Arts portfolio?

Answer:

Services provided to external agencies in 2013 included Employee Benefits expenses for the Art Gallery of Western Australia, the State Library of Western Australia, the Western Australian Museum, and the Perth Theatre Trust. These employees were employed and paid by the Department of Culture and the Arts from Appropriation received for this purpose.

This was recognised in the Financial Statements as 'Services provided Free of Charge (Note 32 Page 122). As a result of the Machinery of Government Change effective from 1 July 2013 (Note 6 Page 103), these employees are now paid directly by their respective agencies. The services provided by these employees to their agencies remain unchanged.

(b) Can the Department provide a breakdown of where the funding was reallocated to source services internally?

Answer:

There was no reallocation of funding to source services internally. As disclosed in Note 6 Page 103, the funding for employees providing services to respective agencies was paid directly by Treasury to the respective agencies.

(c) Does a reduction in record keeping and archival services funding factor in moving materials into digital storage?

Answer:

The budget does not factor in moving archived digital materials from government agencies into digital storage since these transfers are currently not being undertaken.

(d) How many FTEs have been committed to the transfer of archived materials into digital storage?

Answer:

The SRO does not currently transfer archived digital materials from government agencies into storage.

The SRO does however employ one FTE to undertake the management of digitised copies of government archives from the State collection and give advice to government agencies about making, managing and keeping born-digital records.

In addition the SRO is working to develop the policy, technical and administrative framework which will allow, subject to resources, the transfer of unique born-digital government records into a digital archive system to permanently preserve, control and provide appropriate access.

(e) Which specific groups have been impacted by the removal of \$125 000 in Arts Industry Support that was sourced from the Royalties for Regions fund?

Answer:

No groups have been impacted. The funding was allocated to the Regional Arts Touring Boost project, which is ongoing. The project budget is as follows:

- 2014-15 \$444 000
- 2015/16 \$300 000
- 2016-17 \$250 000
- (f) What percentage of the overall state budget was allocated to Arts this year?

Answer:

0.53 per cent of the overall State Budget was allocated to the Culture and Arts portfolio in 2013-14.

Government funding for culture and the arts activity is not solely allocated through the Culture and Arts portfolio. In addition to appropriations through the portfolio, funding is allocated to metropolitan and regional programs and events through Lotterywest, Regional Development, Eventscorp and the Metropolitan Redevelopment Authority. Much of this funding will support arts and cultural activities at a grass roots level, encouraging community engagement and participation.

The State Government has allocated \$428 million for investment in a new museum for Western Australia. Over the forward estimates this investment increases to reflect the capital program with \$140 million in 2017-18.

(g) How does that compare to ten years ago?

Answer:

0.97 per cent of the State Budget was allocated to the Culture and Arts portfolio in 2003-04.

Question No. 7: Hon Lynne McLaren MLC asked -

I refer to "Statement of consolidated Account Appropriations and Income Estimates" on

page 87 of the Annual Report, and ask-

(a) Can the Department list which services were impacted from a decreased net amount

appropriated to deliver services from \$71 561 000 in 2013 to \$38 319 000 in 2014?

Answer:

No Services were impacted. The decrease reflects the accounting treatment of the Machinery

of Government change disclosed in Note 6 on page 103 which moved the appropriation for Employee Benefits expenses from the Department to the Agencies. Please see the answer to

Question 5 for more detail on this change.

(b) How many FTEs were allocated to deliver services in 2013 compared to 2014?

Answer:

2013 FTEs: 604

2014 FTEs: 602.33

Where are the statistics on gender diversity across the management tiers in the Department?

Answer:
