4) For the year 2015/16, by type and location, how many dwellings does the Authority expect to complete under the disability service program, mental health care units program and the mental health commission program?

Answer:

The Housing Authority has no expected completions for the Mental Health Care units program or the Mental Health Commission program for 2015-16.

For the Disability Services Commission program, the Housing Authority expects to complete:

- 2 x 2 bedroom dwellings and 1 x 3 bedroom dwelling in Busselton
- 1 x 4 bedroom dwelling in Mount Richon
- 1 x 2 bedroom dwelling in South Carnarvon.

Two two-bedroom dwellings are expected to be purchased in 2015-16 and a third dwelling will either be purchased or built. However, they are not currently assigned to a district as the clients have not yet been identified by the Disability Services Commission.
