Sundry debtor works are projects undertaken by Main Roads but funded by third parties. These items are often not finalised until the year of delivery.

The \$32 447 increase for 2013-14 was to bring the original estimate closer in line with expected actual expenditure for the year.

All receipts are expected in the same year as the works are undertaken.

The increase in 2014-15 and 2017-18 of \$10m each are to build the base estimate for those years closer to current trend figures.

Question No. 4: Standing Committee on Estimates and Financial Operations asked -

We refer to Budget Paper 3, page 3 - The Government will reduce asset investment spending by \$478 million over the four years to 2017-18 to reflect 'recent low growth in building and construction costs'. Individual program savings are not expected to be known until the 2014-15 mid-year review. However, the agency was not subject to this savings measure, and ask -

a) Why is Main Roads not subject to the Asset Investment Program Efficiency Measure?

Answer: As Main Roads made significant reductions to its 2013-14 to 2016-17 Capital Asset Investment Program prior to the 2014-15 Budget process, the Department of Treasury did not seek the application of the 5 per cent Asset Investment Program Efficiency Measure.

b) Is the agency not expected to achieve savings from 'recent low growth in building and construction costs'

Answer: Main Roads does expect tenders for works to be lower, all things being equal, from previous years with estimates reflecting current rates.

Answer:

Main Roads' core business is as custodian of the State's road network, including providing the road network itself. The road network is the service Main Roads provides to the travelling public and as such it is seen as more appropriate to fully list the services provided by Main Roads in the income statement rather than just a listing of projects within the Asset Investment Program.

As Main Roads' programs are reported against the Total Cost of Services from the income statement, the removal of the entire Capital Works program would severely limit the transparency of the services undertaken by Main Roads.

Answer: None, Main Roads has not been requested to return any funding to the Consolidated Account.

b) What is the reason for the decline in the current value of cash assets between 2015-16 to 2016-17?

Answer: Funds set aside under the State Road Funds to Local Government Agreement were not expended in the year of receipt and thus added to the 'Cash at Bank' figure. When they are called on the 'Cash at Bank' figure will drop. This was estimated to be during the 2016-17 financial year.



I refer to Budget Paper No 2, page 819, "Asset Investment Program - new works", line item Office of Road Safety - LED school zone lights, and ask -

a) How much of the \$36m in the budget for this project over the next three years will be spent in the South West electoral district?

Answer: \$4.5m

b) Which schools in the South West electoral district been identified to receive LED school zone lights in each of 2014-15, 2015-16 and 2016-17?

Answer:. All schools with a 40 km/h school zone will receive LED lights over the next 3 years. The timing of individual installations within this program has yet to be established.

Question No. 23: Hon Adele Farina MLC asked –

I refer to Budget Paper No2, page 819, "Asset Investment Program", line item Total, and ask

a) the total amount to be invested in assets declines by \$115m from 2013-14 estimated actuals to 2014-15 estimated budget and a further \$244m in the 2015-16 estimated budget, why has the investment in assets been cut by \$359million in two years?

Answer: The change in the total Capital Works figure between years is a function of the progress of individual works projects. As projects come to the end of construction the total value of the program 'drops' until other projects move into the construction phase. For example, the Gateway Project itself currently shows a reduction in expenditure of \$134m between 2014-15 and 2015-16. The project has not had a budget cut but rather will just be concluding its major construction activities in 2015-16. Other projects are expected to 'ramp up' construction during 2016-17 and again in 2017-18.
