

 - a) please provide an itemised list all current and projected expenditure of these funds; and

Answer

This project was successfully completed and opened in 2013 There is a current allocation of \$100,000 in 2018/19 and \$285,000 in the forward estimates period, as shown in the State Budget Papers, to cover the contracts defects liability period. These budgeted funds will primarily be used to cover periodic inspections of the works and any minor works required due to consolidation/drainage of the new roadworks.

1) Page 508. What represents the \$15 million saving in 2018-19 for the Northbound from Hutton Street to Cedric Street reallocation from Recurrent to Capital?

Answer^a

There is no change in project budget or scope. The change is an accounting change from a Recurrent budget to a Capital budget to recognise that the road will be capitalised.

2) Page 508 Why is the increase in Motor Vehicle Licence Fee Revenue so significant in 2020-21?

The table below details the total revenue received via the Road Traffic Act 1974 and shows that the increase is not significant in 2020-21.

3) Page 508. What makes up the reallocation from Capital to Recurrent for the Outback Way in 2018-19 and 2019-20?

Answer.

There is no change in project budget or scope The change is an accounting change from a Capital budget to a Recurrent budget to recognise that the road will be controlled by local government and expensed accordingly

4) Page 508 What makes up the significant decreases in road maintenance expenditure, especially in 2020-21 and 2021-22?

Answer:

While growth has been capped, road maintenance expenditure remains \$438 million higher than during the four years up to and including 2016-17. The savings have been set aside to be reinvested in future road projects.
