Supplementary Information No A2: Hon Liz Behjat asked — In reference to State Public Sector employee volunteering, can the department provide information relating to an audit conducted of government sector agencies that are currently using employee volunteering programs.

#### Answer:

In 2009, 181 public sector organisations were surveyed about existing policy and programs to support their employees volunteering and undertaking community service.

A total of 70 replies (38% response rate) to the Public Sector Survey were received.

### **Key Findings**

- 1. Twenty-eight (28) public sector agencies had employee-volunteering, community service or workplace-giving policies or programs that had some degree of formality. Some agencies had combinations of volunteering, fund-raising and workplace giving programs in place.
- 2. Eleven (11) of the twenty-eight agencies had policies or programs to enable staff to engage in community service during work hours, i.e. paid time to undertake community/volunteering work, or to use a combination of paid time and unpaid time to undertake volunteering.
- 3. Eight (8) of the twenty-eight agencies allowed staff to volunteer during working hours on the proviso that workload and working hour requirements were met, i.e. staff were able to use flexi time to undertake community work.
- 4. Three (3) of the twenty-eight agencies had only formal workplace-giving or fund-raising policies and programs.
- 5. Forty-two (42) agencies reported that no policies or programs related to employee volunteering or community service were in place.
- 6. No response was received from one hundred and eleven (111) organisations.
