The Hon Stephen Dawson asked how many positions at DSC have been affected by the government's hiring freeze; that is, the freeze on replacing staff before 1 July 2014? Have any positions been affected; and, if so, what were the positions and where were they?

Answer:

There were 208.67 FTE vacancies at the Disability Services Commission as at 1 May 2014 and these are listed below. This is not atypical. These vacancies are managed through a range of strategies including overtime, contract employees, agency staff and internal acting opportunities.

None of these positions will be filled prior to 1 July 2014. Forty-five positions will be filled when the recruitment freeze is lifted.

Answer:

The Organisations that provide or can provide school holiday respite care in the Pilbara region are:

- Empowering People in Community (EPIC) Karratha, Point Samson, Roebourne and Dampier
- Lifestyle Solutions Aust Ltd Port Hedland, Tom Price, Newman. Intend to expand to Jigalong and other remote Aboriginal communities
- Inclusion WA Inc Karratha.

The Organisations that provide or can provide school holiday respite care in the Kimberley region are:

The Hon Stephen Dawson asked if there is a list for tranche 2 (referring to Economic Audit Committee Component II funding). Can you provide by way of supplementary information a list of those organisations that got the funding and the program they got it for.

Answer:

The Disability Services Commission (the Commission) received \$20.05 million for Component II in 2013/14 and will receive a further \$8 million in 2014/15 to be allocated from 1 July 2014. The allocations received from the Department of Treasury were based on the Commission's Agency Implementation Plan approved by the Minister. The Plan provided Component II funding for individuals with complex needs, who are historically underfunded, have changed needs or live in regional or remote areas. Funds have been allocated to organisations that entered into new Service Agreements with the Commission that align with the Delivering Community Services in Partnership policy and in line with the Agency Implementation Plan parameters.

The Hon Ken Travers asked how much the Commission spends on the 'Continence Management Aids Support Scheme' in a total year.

Answer:

The Disability Services Commission (the Commission) budget for the adult Continence Management and Support Scheme (CMASS) was \$3,897,607 in 2013/14. This includes \$1 million (non-recurrent) committed by the State Government in 2013/14 and an additional \$230,000 (non-recurrent) allocated to the Scheme by the Commission to address unmet demand.

A further \$1,603,170 was spent to support two children's continence services - the Incontinence Pad Scheme for Children aged 0 to 16 years and PEBBLES Children's Continence.

A total of \$5,500,777 was allocated to all continence services in 2013/14.

In the 2014/15 State budget, the State Government has committed a further \$2.5 million to the Continence Management and Support Scheme (CMASS) giving a total of \$4,950,257 in 2014/15 (compared to \$3,897,607 in 2013/14).
