4) How many Multi-Purpose Taxi drivers are currently licensed to drive MPTs by gender?

Answer: As at 26 October 2015, there are 20 out of 597 currently licensed MPT drivers that are female.

Answer: Whilst it is hard to determine exactly how many male and female MPT drivers are currently driving; as at 30 September 2015, there were 4 out of 95 MPT lease plate holders that are female.

Answer: 26 complaints made by passengers:

- 15 resulted in No Offence;
- 2 infringements were issued;
- 5 cautions were issued;
- 1 was referred for prosecution, but was dismissed;
- 2 complaints about the same driver were referred for a review of the driver's suitability to hold a T endorsement, resulting in the driver being prohibited from driving taxis;
- 1 is still under investigation
- 7) How many of these complaints were referred to external agencies for investigation and what was the outcome of these?

Answer: Just the one referred for prosecution. The prosecution was dismissed.

8) Of the 8 complaints that were 'under investigation' 1 July 2014-26 Feb 2015, what issues were these regarding and what was the outcome of each?

Answer:

- Driver behaviour. Complaint was referred for prosecution, but the prosecution was dismissed.
- 2 complaints were for the same driver regarding driver behaviour. There was insufficient evidence to indicate bad character, but DoT requested driver to do a psychological assessment, which was never completed. A notice of 'failing to comply' is to be served on the driver.
- Suspected TUSS Fraud. Evidence is being gathered, still under investigation.
- 2 other drivers were suspected of TUSS fraud. Insufficient evidence to establish an offence.
- Parking illegally and behaviour. Complaint was withdrawn/dismissed.
- Driver behaviour. No offence was established.
