The inquiry into end of life choices

For almost six months now, a Parliamentary committee has been inquiring into the need for laws in Western Australia to allow citizens to make informed decisions regarding their own end of life choices.

The Committee is very pleased to advise that all submissions made to the inquiry have now been reviewed and, other than those which are confidential, are available to the public on the Committee's website at www.parliament.wa.gov.au/eolcc

The Committee Chair, Ms Amber-Jade Sanderson MLA, stated:

We have more than 650 submissions available on the Committee website. As far as we are aware, this is an unprecedented number of submissions for a Legislative Assembly inquiry and shows the very significant public interest in end of life choices.

We are now continuing with public hearings, examining the practices used by the medical community for patients at the end of their life, and inquiring into the existing laws relating to end of life choices. We will also be exploring whether reform is needed, including hearing from vulnerable groups in our community.

The public hearings will be conducted between Monday, 26 February 2018 and Friday, 2 March 2018 in Perth. The first regional hearings will be held in Albany during the following week.

During the week commencing 26 February 2018, the Committee will be taking evidence from service providers, academics and representatives of vulnerable groups, as follows:
