The following is an extract from Schedule 1 of the Legislative Council Standing Orders:

3. Estimates and Financial Operations Committee
 - 3.1 An Estimates and Financial Operations Committee is established.
 - 3.2 The Committee consists of 5 Members, 3 of whom shall be non-Government Members.
 - 3.3 The functions of the Committee are to -
 - (a) consider and report on -
 - (i) the estimates of expenditure laid before the Council each year;
 - (ii) any matter relating to the financial administration of the State; and
 - (iii) any Bill or other matter relating to the foregoing functions referred by the Council;
 - and
 - (b) consult regularly with the Auditor General.
