Concerns that robert Bropho of the swan Valley Ny00ngar community is still a cause for concern and has tremendous influence and control over the residents and that there is potential for another death or assault at the campsite.

ACTION TAKEN:

Over the past 4 years years Police at Kiara have made many inroads to gain entry unimpeded inorder to perform their duties . Police have broken down the barriers that were put up before by BROPHO and his advisers and now have a good working relationship with these people.BROPHO is still very guarded

about giving out information as to the where abouts of family mambers when police have cause to look for them but this barrier is slowly coming down and over the past year information has been a lot more free.

Since the outcomes of the Gordon Inquiry police along with other agencies have had regular meetings to implement strategies to break down the barriers so that the individual agencies may enter the campsite unimpeded and carry out their resepctive functions.

some of these meetings have included BROPHO on an individual level but this committee is having problems with getting BROPHO and his advisers to attend a joint agency committee meeting.

FOLLOW UP ACTION REQUIRED:

There is a joint agency committee meeting on the 18/3/03 where further discussions as to getting BROPHO on side to attend a combined agency meeting.

It is my opinion that BROPHO is trying to conform with the findings of the Gordon Inquiry and is slowly coming around to working in with other Government agencies .We as Police are not experiencing any major problems with the campsite or BROPHO at present.
