An Act to amend the *Consumer Credit (Western Australia) Act 1996* and for related purposes.

The Parliament of Western Australia enacts as follows:

#### 1. Short title

This Act may be cited as the *Consumer Credit* (Western Australia) Amendment Act 2001.
