## Dear Dr Woollard

Thank you for your correspondence of 12 and 15 June 2009 in regard to the review of Western Australia's current and future hospital and community health care services.

In order to respond to your specific questions, I sought advice from senior ACT Health officials and I am advised as follows:

The Personal Health Record (known colloquially as the "Blue Book") is provided to all new parents in the ACT through the Child, Youth and Women's Health Program in Community Health.

The Blue Book includes important health information for parents and details a child's health, growth and development, including the child's immunisation record and developmental screening test results. The Blue Book is used universally in the ACT and there are no other documents of this nature specific to indigenous families.

A project has commenced to review the Blue Book and to develop a revised version through consultation with parents and a range of health professionals. It is anticipated that this work will be completed by February 2010.

The ACT Health organisation chart which includes community based health services is attached (Attachment B). A breakdown of staff speciality in Community Health is also attached (at Attachment C). There are no specific guidelines or targets for client/staff ratio for these specialties.
